 - All utility line locations above and/or underground when possible
 - Any other pertinent features / information (bodies of water / wetlands / steep grades, etc.)
- Three Sets of Building Plans – No larger than 24" x 36"
- Copy of Applicant Driver's License
- Copy of State Contractor's License
- Copy of Liability Insurance Certificate
