### INTRODUCTION AND HISTORY

The Auburn Hills Fire Department respectfully requests approval to purchase a new ambulance to support the continued delivery of high-quality Emergency Medical Services (EMS) to our community. This request aligns with the City's established fleet replacement schedule, developed collaboratively by the Department of Public Works (DPW) and the Fire Department.

The ambulance to be replaced is a 2015 Chevrolet unit with approximately 130,000 miles. This vehicle will be retired from active service. The department currently operates three (3) frontline ambulances and one (1) reserve ambulance. The most recent replacements occurred in 2020, 2021, and 2023, with those vehicles now approaching 80,000 and 40,000 miles respectively. The proposed ambulance will enter frontline service, and the Fire Department will work with the Fleet Division of the Department of Public Works to determine which ambulance within our fleet should transition to reserve status.

Since the introduction of EMS services in 2014, the department has responded to more than 30,000 medical emergencies. Maintaining a reliable and standardized fleet is essential for meeting growing service demands. This purchase will be made through the Sourcewell Government Cooperative Purchasing Program, which the City has successfully used in prior vehicle and equipment acquisitions. Sourcewell streamlines procurement by satisfying competitive bidding requirements and offering pre-negotiated contracts with reputable vendors.

The selected vendor is Emergency Vehicles Plus (EVP), a Michigan-based dealership and sales representative for Wheeled Coach Industries, Inc. The total cost of the proposed ambulance is \$425,289.00, with specifications identical to the last three ambulances purchased. This ensures operational consistency and simplifies maintenance and training across the fleet.

In addition to the ambulance purchase, the Fire Department requests approval of \$3,375.00 for the application of department-specific graphics. This work will be performed by Majik Graphics of Clinton Township, a trusted vendor used consistently by both the Fire and Police Departments. Majik Graphics has demonstrated high quality and cost-effectiveness in previous projects.

Wheeled Coach Industries, Inc. operates a 311,000 sq. ft. ISO 9001:2015-certified facility in Orlando, Florida. The company produced over 1,000 units in the past year and maintains membership with the Ambulance Manufacturers' Division (AMD) of the National Truck Equipment Association (NTEA).

Emergency Vehicles Plus (EVP) is a full-service emergency vehicle dealership with a strong track record of service and support. The Fire Department has previously purchased ambulances and fire apparatus through EVP, with consistently positive experiences.

#### **STAFF RECOMMENDATION**

Staff recommends to the Public Safety Advisory Committee the approval to purchase of a Wheeled Coach ambulance from Emergency Vehicles Plus in the amount of \$425,289.00 and graphics work performed by Majik Graphics in the amount of \$3,375.00

### INTRODUCTION AND HISTORY

Historically, the Police Department has employed various strategies to manage motorist speed within neighborhood areas and business districts. One of the most effective tools in this effort has been the use of radar speed trailers. These trailers are easily deployed and repositioned throughout the city, providing motorists with immediate speed awareness and enhancing traffic safety.

Thanks to solar-powered charging systems, the speed trailers can remain operational in the field for extended periods. Many units are also equipped with changeable message sign capabilities, allowing the department to provide timely public notifications. These may include alerts about upcoming special events, road closures, and emergencies requiring traffic redirection.

Currently, the Police Department operates two radar speed display/changeable message sign trailer units, both of which are in regular use throughout the year. They have proven to be invaluable not only for traffic enforcement but also for community engagement and public safety messaging. These trailers are regularly deployed during major city events such as Avondale Homecoming, the Memorial Day Parade, Summerfest, the Holiday Tree Lighting Ceremony, and Black Friday shopping, among others.

However, one of the existing trailers is now 11 years old and experiencing ongoing maintenance issues, significantly reducing its reliability and effectiveness. Recognizing the importance of this equipment, the department included a request in the 2025 budget to replace the aging unit.

With the approval of the 2025 budget, the Police Department is prepared to proceed with the purchase of a new radar speed display/changeable message sign trailer. This investment will ensure the continued effectiveness of traffic safety and communication efforts across the city.

On April 2, 2025, an invitation to bid was placed on BidNet Direct for the contract to provide a new radar speed display/changeable message sign trailer. The closing of the bid was May 1, 2025, at 1:00 p.m. at the City of Auburn Hills City Clerk's office. Three (3) vendors responded with sealed bids.

\$25,000.00 was approved in the 2025 approved budget for the police department to purchase a new speed display trailer/changeable message sign.

The department recommends selecting **Applied Concepts, Inc.** as the vendor for the purchase of the new radar trailer/changeable message sign. The Police Department has an established and positive relationship with Applied Concepts, having previously acquired several handheld LIDAR devices from the company.

Applied Concepts has consistently demonstrated excellent customer service, with responsive communication, knowledgeable support staff, and a willingness to engage directly with department personnel to discuss equipment needs and capabilities. The quote provided by Applied Concepts for the new speed trailer meets all bid specifications and operational requirements outlined by the department.

The changeable message sign would come equipped with the following items:

- Large 4' X 8' display for messages and speed notifications.
- Red and blue strobe lights to alert speeding motorists.
- The changeable message sign has the ability to change the message remotely. Subscription is required, but the 1<sup>st</sup> year is free. Renewal is \$284 per year.
- Electric winch to raise and lower the display sign.
- 230-Watt solar panel which allows the unit to complete a recharge in 4 hours of sunlight.
- 5-year warranty on the trailer & solar power. 1 year warranty on the battery.
- The radar sign is trailer mounted.
- The trailer and radar sign both have an anti-corrosion paint package.

#### **STAFF RECOMMENDATION**

Applied Concepts, Inc. beat the other supplied quotes in the bid, and they met all of the specified bid requirements. It is recommended to approve the purchase of the radar speed display/changeable message sign trailer from Applied Concepts Inc.

Subject: Purchase of Microphones for Motorola Radios

### INTRODUCTION AND HISTORY

In August 2023, the Auburn Hills Police Department switched to the new Oakland County P25 radio system for everyday operational communications. The radios and accessories were largely provided through Oakland County based on the number of full-time employees and vehicles at that time. Each radio was outfitted with basic accessories that included speaker microphones for the portable radios. However, once our officers started using the radios for patrol functions, it became apparent that the microphones provided were inadequate in busy or high noise environments and did not provide the ability to change radio settings without handling the radios causing safety concerns. Patrol staff acquired several other models of speaker microphones from Motorola. Based on a thorough review over a period of several months it was determined that two shoulder microphone models best fit our needs. As members of CLEMIS (Courts and Law Enforcement Management Information System), the police department is eligible to purchase additional equipment from Mobile Communications America (MCA, formerly ComSource Inc.), the local Motorola vendor, at the same pricing awarded through the County's competitive bid.

A quote was obtained from MCA for 10 Motorola APX wireless speaker microphones and 40 Motorola XVP830 corded speaker microphones at a total cost of \$19,350.00. These speaker microphones offer louder speakers, greater noise suppression, and buttons that allow for radio settings to be adjusted without having to remove the radio from the holster.

### STAFF RECOMMENDATION

Staff recommends the purchase of 10 Motorola APX wireless speaker microphones and 40 Motorola XVP830 corded speaker microphones from Mobile Communications America utilizing the Oakland County Bid.

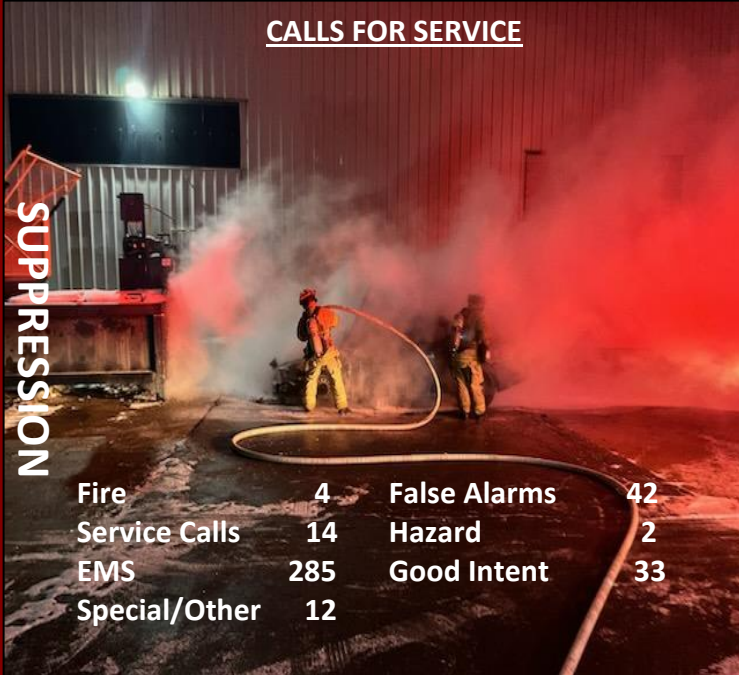

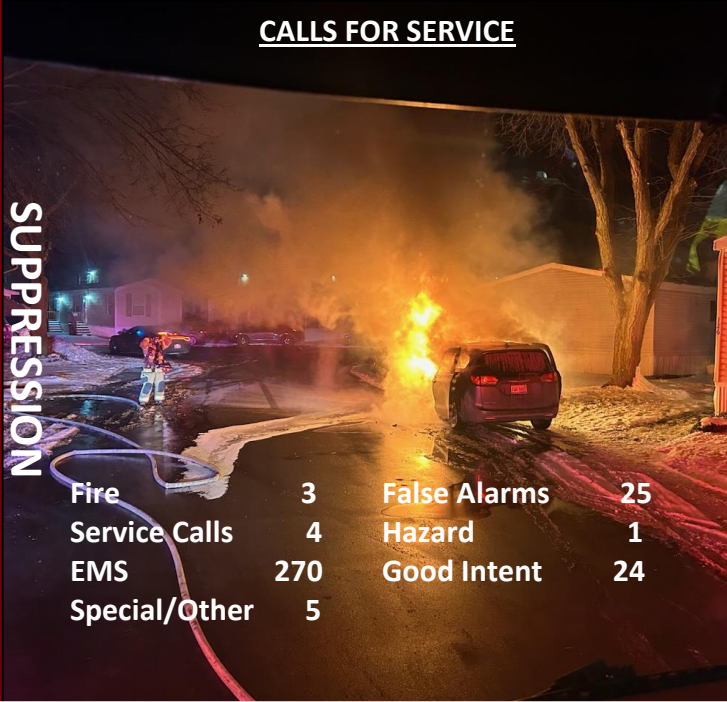

## Training

2/04/2025

Auburn Hills Fire Department personnel are committed to thousands of hours of training each year. In 2024, over 1,000 hours each month on average, were spent training. The first few months of 2025 provided the first responders with the opportunity to train at Stations 1 and 3, prior to the remodel, using a K12 saw to breach a metal door. The winter weather also allowed for cold water rescue training in a local body of water.



## Residential Fire

2/10/2025

A-shift was called for a residential structure fire. Engine 3 and Rescue 2 arrived at a small 2-story structure, with nothing showing from the exterior. It was reported that everyone was out, and the building was filled with smoke. E3 stretched a hose from the engine for fire control and R2 and Lt.1 located the fire in the kitchen, inside the oven. The fire was quickly extinguished. The home was then ventilated and turned back over to the residents.

## Vehicle Crash

2/12/2025

B-shift was dispatched for an injury accident on Lapeer Rd. Upon arrival the driver was discovered to have an open ankle fracture and a shattered femur. Rescue 2 immediately transported the patient to a nearby hospital for further treatment.



## Vehicle Fire

2/27/2025



C-shift was toned for a vehicle fire on Baldwin Road near I 75. The vehicle started smoking, then the brakes went out, according to the driver. The driver was able to pull over and noticed the car had caught fire. Firefighters quickly worked to extinguish the flames with tank water and foam from Engine 3. There were no reported injuries.

Turnout Time for Fire Incidents

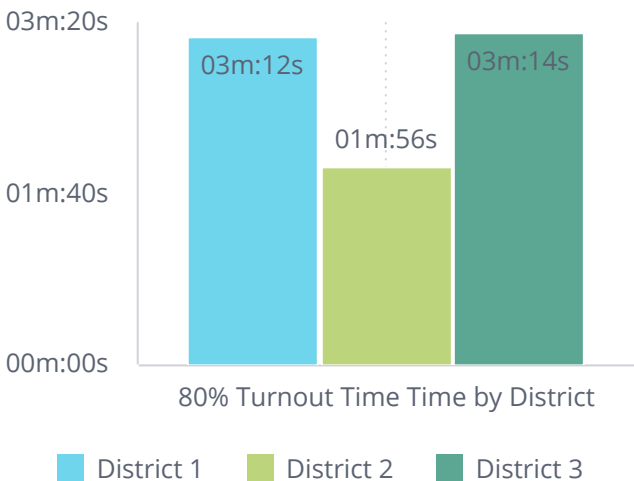

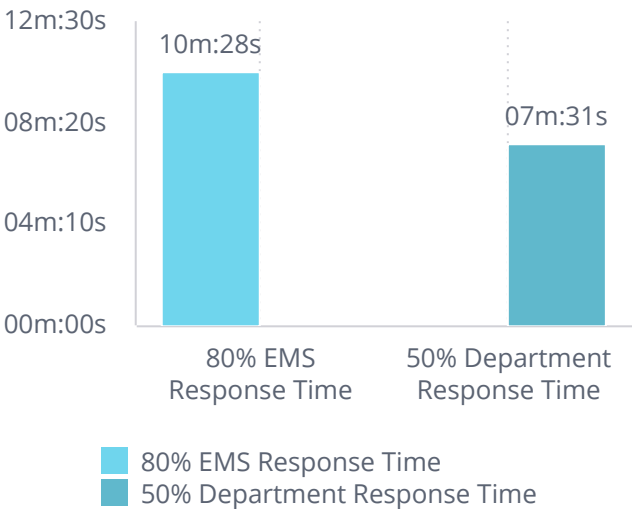
Department Chute Times for All EMS Incidents



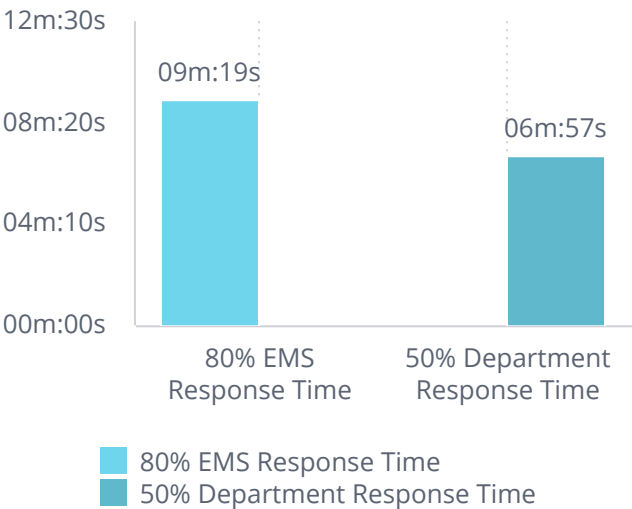

Turnout Time for Fire Incidents

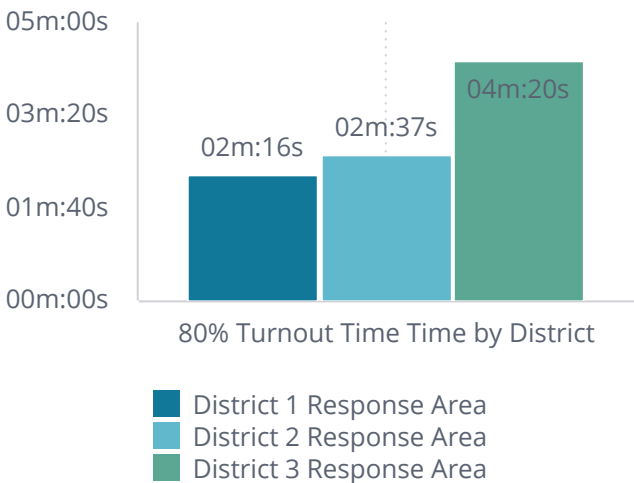

## Monthly Report: February 2025

### Saved from Drowning

On February 1<sup>st</sup>, officers were dispatched to the Crowne Plaza Hotel for a report of a six-year-old female who had been pulled from the pool after becoming unconscious while struggling in the water.

Officer Eckel was the first to arrive and found that the victim had a weak pulse and weak breathing. The victim was transported to the hospital, where she fully recovered.

The investigation determined several children were in and around the pool for a party. A family member of the victim had set the victim on the ledge of the pool, and the victim fell in without anyone noticing. A video review showed that the child was underwater for approximately four minutes before an adult noticed and pulled her to safety.

### Malicious Destruction of Property

On February 12<sup>th</sup>, officers responded to a report of a male attempting to break into cars in the parking lot of Great Lakes Crossing Outlets. Officers located the suspect walking nearby on Baldwin Road.

The suspect had broken mirrors and windows on several vehicles in the parking lot, causing over \$1000 in total damages. The suspect, a 24-year-old male from Detroit, admitted to causing the damage and said he'd done so because he was angry about his cell phone getting stolen.

The Oakland County Prosecutor's Office authorized charges for Malicious Destruction of Property greater than \$1000, a felony.

### Assault & Carrying a Concealed Weapon

On February 4<sup>th</sup>, School Resource Officer Saikalis was informed by school staff of a possible stabbing that had taken place in one of the school restrooms. The victim, a student at the school, was reported to have been stabbed in his leg during a fight.

The victim told a school staff member about the incident, and then he was picked up from the school by his guardian before he could be interviewed by police. He was later interviewed at the hospital.

The suspect, another student, left the school after the incident without the knowledge of the school staff. The weapon, a kitchen knife, was later recovered from the bathroom hidden inside a toilet paper dispenser.

The suspect, a 16-year-old male from Pontiac, was located at a family member's house in Pontiac and arrested. The suspect had a documented history of school behavior problems at Avondale.

The Oakland County Juvenile Court authorized charges for Assault to do Great Bodily Harm Less than Murder, Carrying a Concealed Weapon, and Weapon in a School Zone.

### Crisis Outreach

On February 24<sup>th</sup>, a female, known to be homeless in the area, came into the lobby of the police department. She was having delusions and shouting at the police department staff about numerous topics. She refused to acknowledge that she needed to seek mental care.

Co-Responder Sydney Sjogren was on duty and obtained a court order so that officers could compel her to get treatment. She was transported to Common Ground and she is in the process of being set up for long term treatment.



## Human Trafficking & Prostitution

On February 18<sup>th</sup>, Officer Brasil responded to an ad that someone had posted on an internet site for prostitution. He located the suspected prostitute at the Comfort Suites hotel, and she admitted to advertising for paid sexual acts. She had been driven to the hotel by a male acquaintance who was collecting part of her proceeds.

The suspected prostitute, a 26-year-old female from Flint, was arrested for an outstanding warrant. The Oakland County Prosecutor's Office later authorized charges against her for Prostitution.

The driver, a 44-year-old male from Lansing, was arrested. The Oakland County Prosecutor's Office authorized charges for Human Trafficking.

## Armed Robbery

On February 27<sup>th</sup>, officers were dispatched to Genes Drive for a caller reporting that he had been robbed with a gun. The victim was a marijuana delivery driver and was in the process of delivering an order when he was approached by the suspect.

The suspect approached the victim on foot, made a threatening statement, implied that he had a gun, and demanded that the victim give him the marijuana from the delivery.

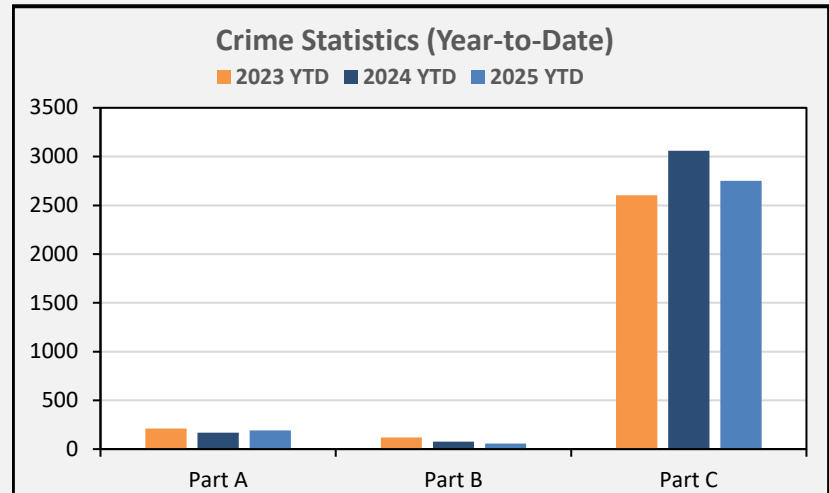
The victim provided police with the telephone number used to order the delivery. The number belonged to a male known to officers to be staying at the Suburban Studios Hotel.

The suspect, an 18-year-old male from Auburn Hills, was located and arrested at the hotel. His accomplice, a 15-year-old male from Auburn Hills, was also taken into custody. The stolen marijuana was found in their hotel room.

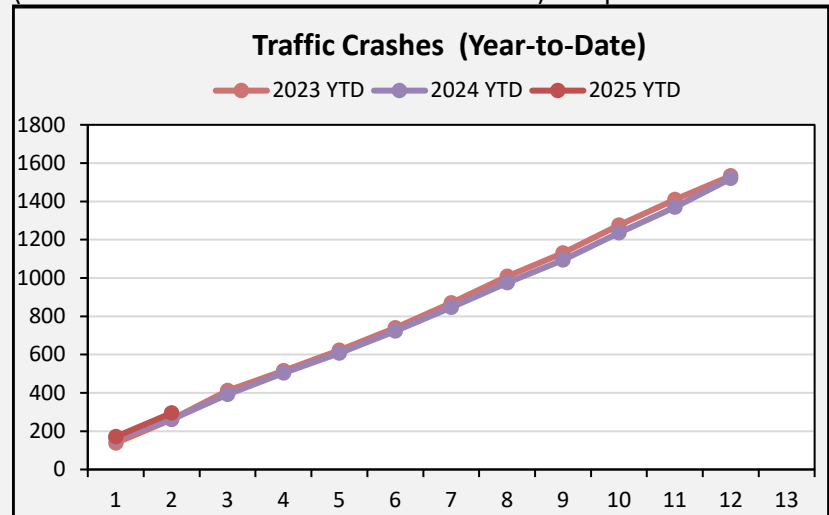
The Oakland County Prosecutor's Office authorized charges for the 18-year-old male for Armed Robbery. The 15-year-old male was also charged with robbery.

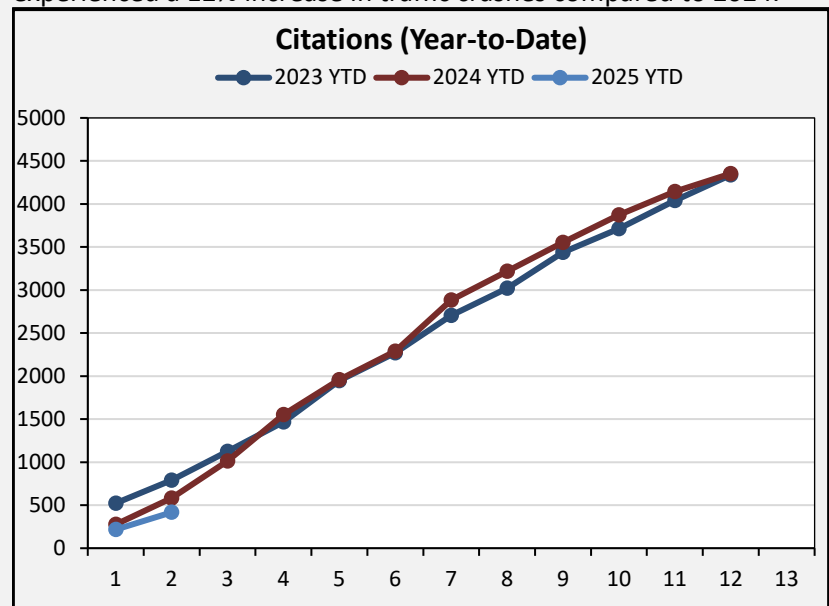

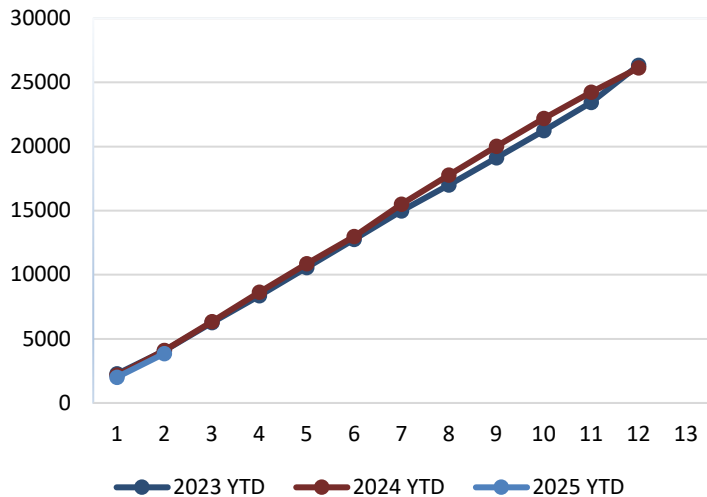

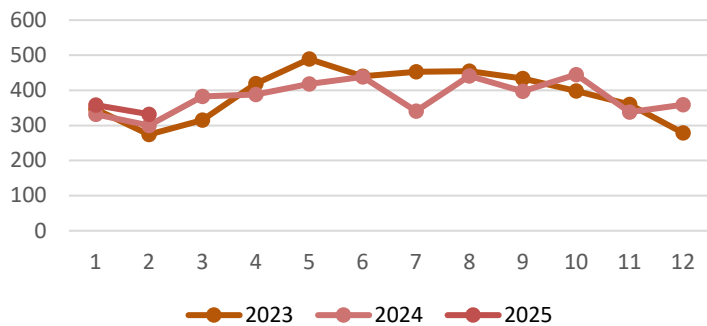
### Calls for Service (Year-to-Date)

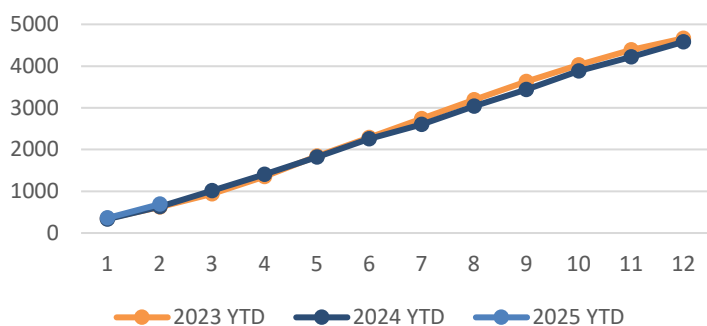

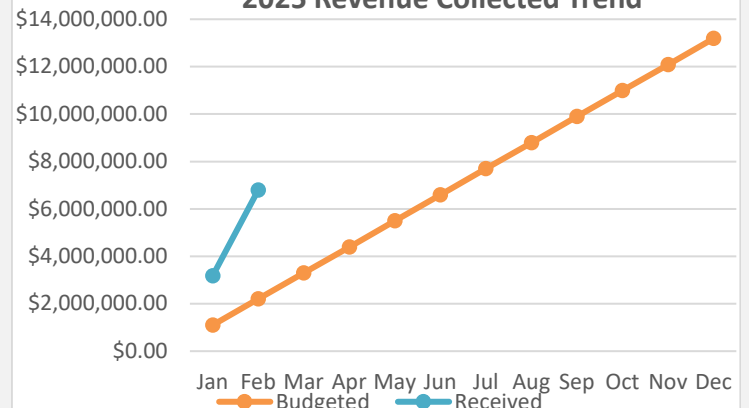

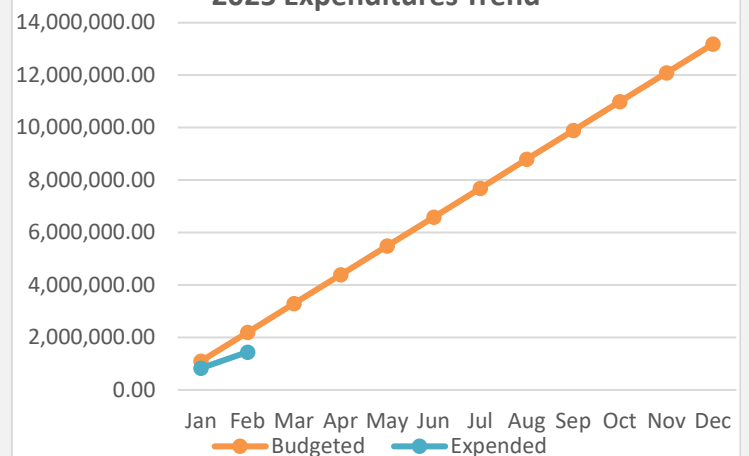

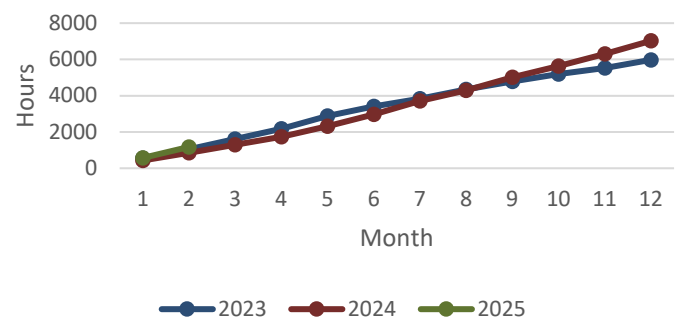

### Concealed Weapons

On March 6<sup>th</sup>, Officer VanVeelen was dispatched to Twin Peaks restaurant for a report of a disturbance between customers involving a gun. When he arrived, the suspects had left the area. The victim reported that they argued with a suspect inside the restaurant, then saw and heard the suspect rack a pistol in the parking lot. As officers were leaving, the suspects returned to the restaurant and were apprehended. Three pistols were located inside the vehicle. The suspects were both from Alabama.

The Oakland County Prosecutor's Office authorized charges for Carrying Concealed Weapons.

## Mental Health Call

On March 6<sup>th</sup>, officers were dispatched to a residence on Auburn Road for a caller who was reporting that a friend was suicidal and homicidal. The person of concern had threatened “suicide by cop” using a gun and said she would drive off a cliff with her children. Officers established contact with the person of concern, a 37-year-old female. She was not suicidal or homicidal but was experiencing mental health struggles.

With assistance from co-responders, arrangements were made for her to be taken to a facility where she could get help for her and her children.

## Homicide

On March 7<sup>th</sup>, officers responded to the Holiday Inn on Baldwin Road for a report of a disturbance in a hotel room involving a gun. As officers were arriving at the hotel, they heard two gunshots from the hallway near the hotel room. Officers made entry into the room to find a 33-year-old male and a 34-year-old female, both deceased, with gunshot wounds. A three-year-old child, the daughter of the female victim, was found inside the room and was unharmed. The investigation determined that the male shot the female victim and then took his own life.

The child was released to family.

## Child Sexually Abusive Activity

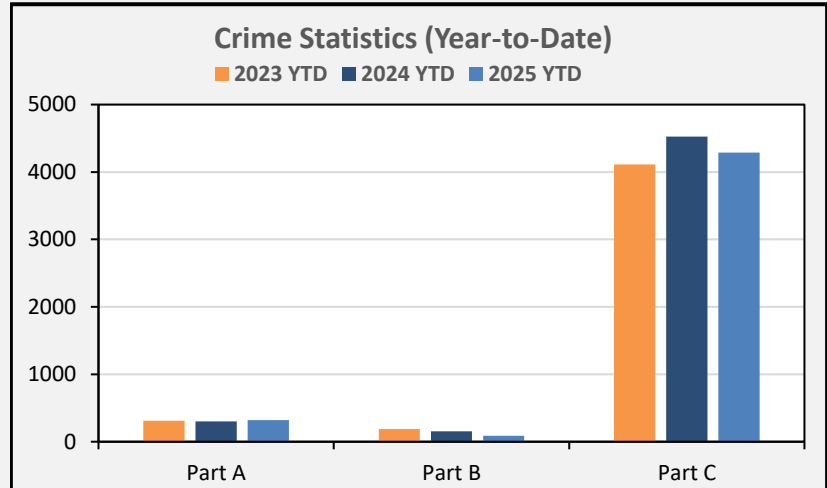
On March 18<sup>th</sup>, officers were dispatched to Target on Brown Road. The caller, who was under 18 years old, found a note on her car that was sexually explicit. Officers contacted the telephone number on the note. The suspect agreed to meet with the victim for sexual acts, even after being informed that the recipient of the note was under 18.

When the suspect was located, he had a substance believed to be methamphetamine. He was arrested.

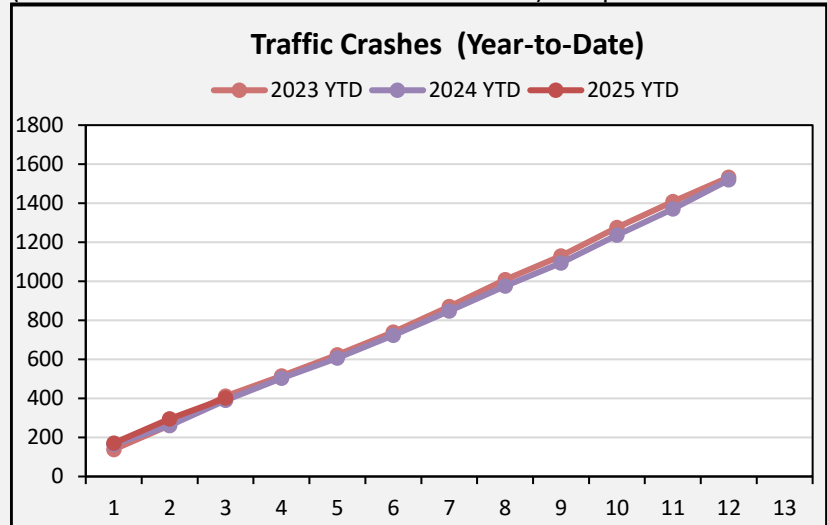

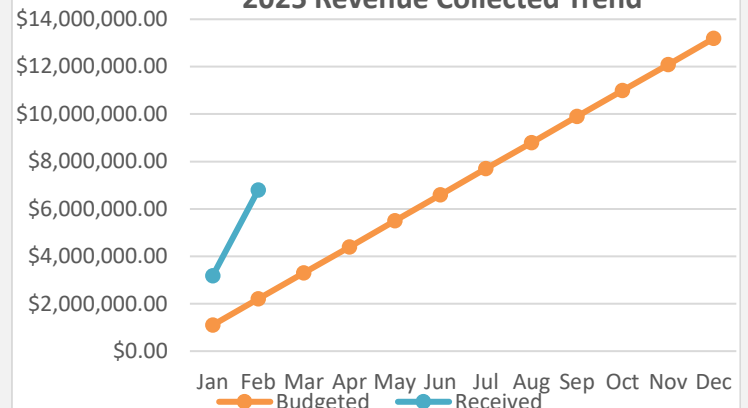

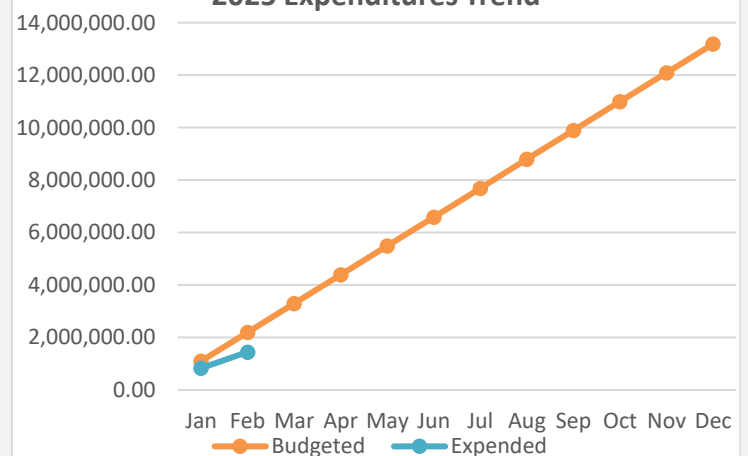

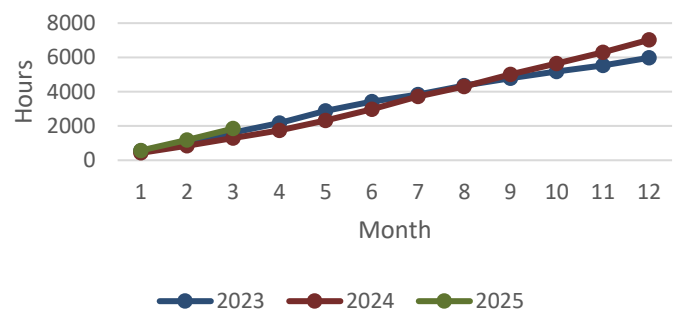

### Take Your Child to Work Day

On April 24<sup>th</sup>, city employees brought their children to work for a day of hands-on learning, which included a tour of the police department and an overview of police operations.



### Found Explosives

On April 11<sup>th</sup>, a resident on Simmons Circle was clearing out belongings from her deceased husband when she found a box of dynamite and blasting caps. Officers assisted the resident with vacating the home until the Bomb Squad from Michigan State Police arrived and took possession of the items.

### Prostitution

On April 13<sup>th</sup>, Officer Brasil located an advertisement on the internet for a female who was offering paid sexual acts within Auburn Hills. She was located at a local hotel, where a male, a 42-year-old from Sterling Heights, accompanied her. After interviewing both parties and investigating further, evidence showed that the female offering sex acts was being controlled by the male, as he was answering ads on her behalf and driving her to "dates".

The Oakland County Prosecutor's Office authorized charges for the male for Prostitution/Transporting a Person.

### Attempted Home Invasion

On the evening of April 16<sup>th</sup>, Officers O'Connell and Sims were dispatched to a residence on Bloomfield Lane for a report of a male who was trying to break into an apartment.

The victim explained that her former boyfriend, a 30-year-old male from Detroit, had come to her apartment and was aggressively beating on her door and threatening to break a window with a rock. He had also sent text messages threatening to break in and to cause her bodily harm.

The Oakland County Prosecutor's Office authorized charges for Attempted Home Invasion & Malicious Use of a Telecommunication Service.

Domestic Assault

On April 22<sup>nd</sup>, officers from the Delta platoon were dispatched to the Red Roof Inn on Opdyke Road for a 911 call that was made with a male and female yelling in the background. The male could be heard stating that officers would have to enter the room with guns drawn. Officers contacted the parties and spoke with the male through an open window. He was wielding a knife, and Officer Pointer successfully persuaded him to disarm himself using verbal skills. The female explained that the male, a 36-year-old from Auburn Hills, had become irate and struck her in the head, which was what prompted the 911 call.

The Oakland County Prosecutor’s Office authorized charges for Domestic Violence, 3<sup>rd</sup> offense.

Breaking & Entering

On April 29<sup>th</sup>, Officers Lane and Duggar were dispatched to United Machining Wescast on University. A store employee found an unknown person inside the building as they were doing a walk-through. Officers located the suspect, a 30-year-old male from Detroit, in an office where he appeared to have set up sleeping quarters. The suspect was uncooperative with officers and refused to answer questions. As he was being placed under arrest, the suspect spat on our officers.

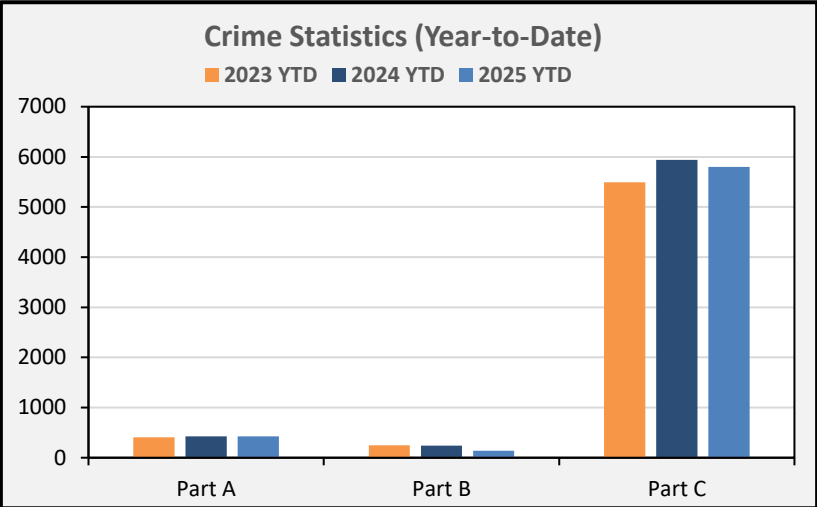
The Oakland County Prosecutor's Office authorized charges for Assaulting a Police Officer and Breaking and Entering.

Terrorist Threats

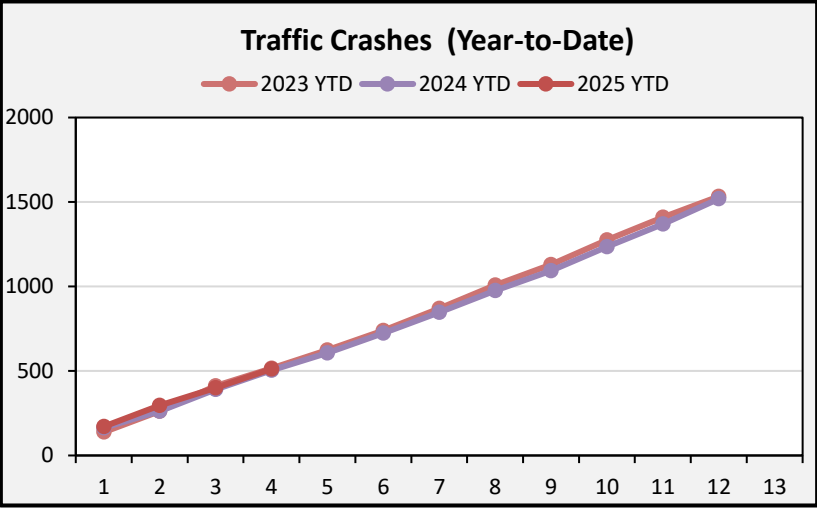

Crime and Service Statistics

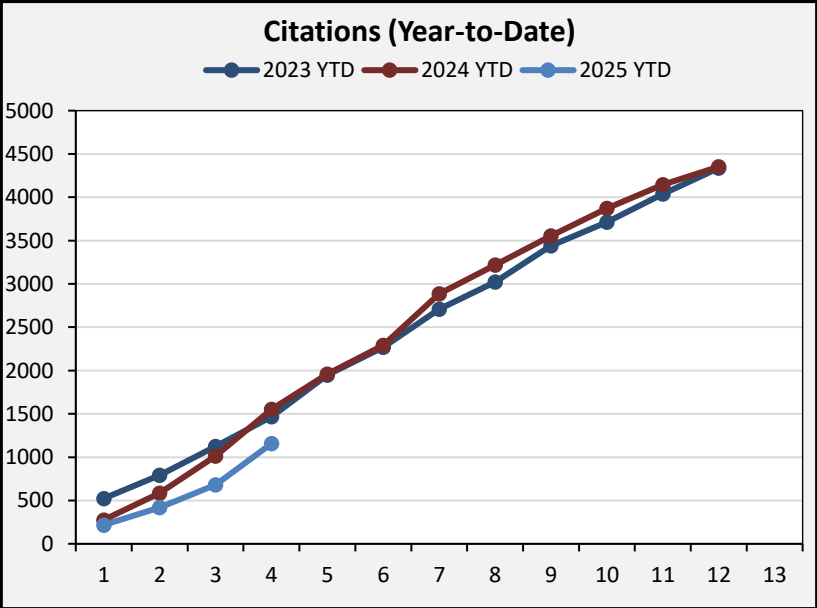

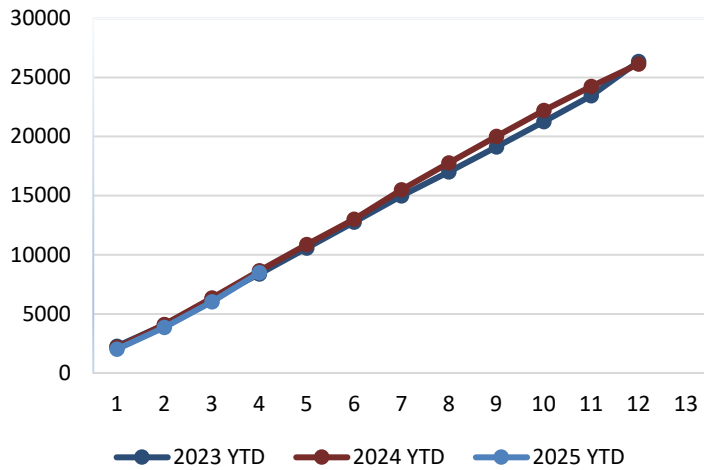
During April, we handled 111 crashes. Year to date we have experienced a 2% increase in traffic crashes compared to 2024.

## Calls for Service

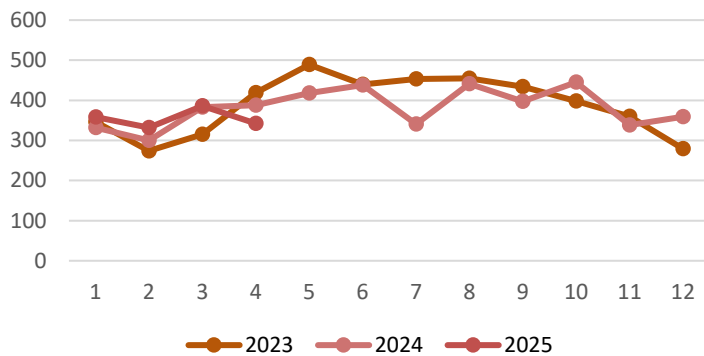
### Calls for Service (Year-to-Date)



Officers handled 2463 calls for service during April. Year to date the department has handled 8474 calls for service, which is a 2% decrease compared to 2024.

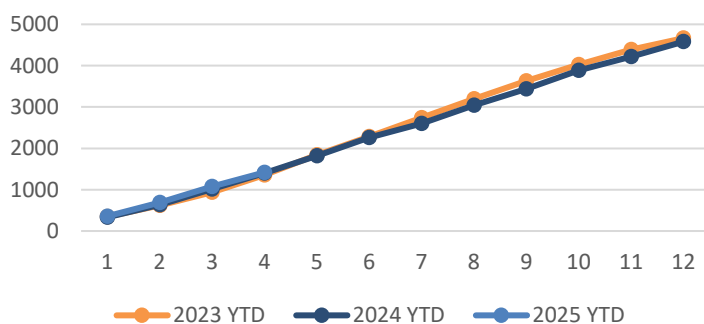
## Time in Neighborhoods

### Cumulative Time in Neighborhoods (Year-to-Date)

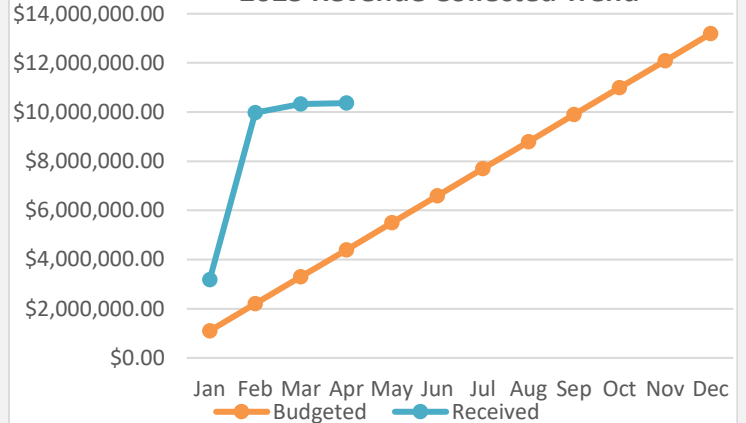


Year to date we have spent 1418 hours in our neighborhoods, which is a 1% increase compared to 2024.

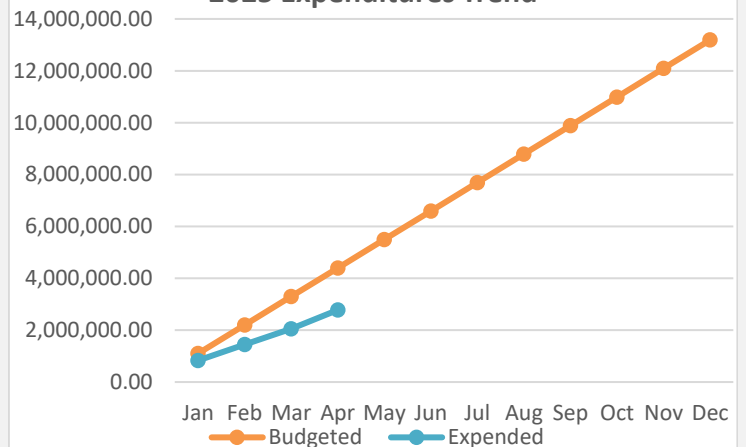
We continually analyze our department expenditures to ensure we remain within our approved budget, while delivering the best possible service to our community.

During April, we received \$34,939 in revenue. Year to date we have received \$10,336,249.

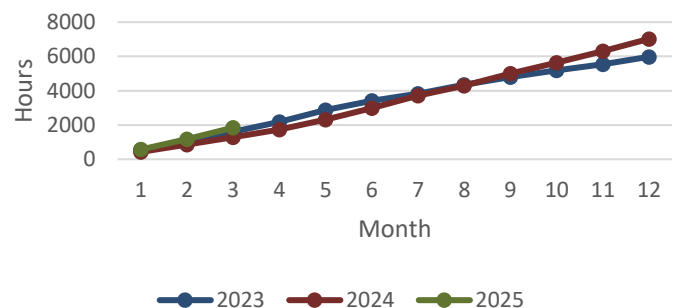
### 2025 Expenditures Trend
