- a. **Consider the Approval to Purchase one 2026 Wheeled Coach Ambulance.** This item was presented by Fire Department Administrative Officer Owen Milks.
 - a. AHFD currently operates 3 front line ambulances and 1 reserve. Looking to replace the reserve.
 - b. The reserve is a 2015 vehicle with over 130,000 miles on it.
 - c. Sourcewell provided a quote of \$425,289.
 - d. The vehicle can be provided within 10 to 12 months from the date of order through Emergency Vehicles Plus.
 - e. Majik Graphics will provide the decaling for \$3,375.
 - f. DPW prefers to remove vehicles from service at the 80,000-mile mark.
 - g. DPW recommends replacing rescues every 2 years until we get on a cycle for the rescues to be replaced at the 80,000-mile mark.

Discussion with questions and answers ensued including which rescue would then be moved to reserve, where rescues are currently located, standardization of all rescues currently in service, maintaining the same layout, warranty, and the DPW fleet replacement schedule.

Subject: Detention Intercom System Replacement

INTRODUCTION AND HISTORY

The intercom system is critical for maintaining safe and secure conditions while in the detention area. It enables officers to communicate with Cadets and Front Desk personnel regarding door unlock procedures, safe operation while navigating the detention area, and for general communication purposes, eliminating the need for the use of a cellphone, telephone, or radio while handling a prisoner.

The detention area in the Public Safety building has been using the originally installed intercom system from 2001 until late 2024, when it stopped working, and support for it ended. During the 2025 budget planning process, we researched the costs of replacing this system. The 2025 approved Police Budget includes \$40,000 to replace the intercom system. A request for bids (RFB) was placed on BidNet Direct on July 17, 2025, for the purchase and installation of eleven (11) interior wall mounted push button intercom stations, one (1) exterior wall mounted push button intercom station, four (4) voice activated intercom stations, and one (1) intercom control station. A required pre-bid meeting was attended by representatives of all three companies submitting bids for this project. During this meeting, they were provided with a detailed explanation of the project requirements and expectations and were given an opportunity to inspect the areas where devices were specified. The closing of the RFB was August 14, 2025, at 10:00 a.m. at the City of Auburn Hills City Clerk's office.

Three bids were received:

*After the bid opening, the lowest bidder (AllPro Audio Video) requested to rescind their bid as they had omitted several items that would prevent completion of the project.

The lowest bid submitted by AllPro Audio Video did not meet the requirements for the required hardware. The company requested that their bid be rescinded. The other two bids submitted were very competitive with each other. Upon reviewing those two bids, it was determined that the next lowest bidding company offered better hardware and warranty solutions than the other. The bid received from RedGuard Fire & Security meets all the required bid specifications, and we are recommending it because of the following features and value-added benefits:

- High security-rated intercom stations with anti-tamper detection
- Echo and noise-cancelling microphones
- Touch screen control station that can be desk or wall-mounted
- Built-in cybersecurity features
- Included warranty: 5-year hardware, 90-day labor

STAFF RECOMMENDATION

Staff recommends the bid be awarded to RedGuard Fire & Security for the purchase and installation of eleven interior push button intercom stations, one exterior push button intercom station, four voice-activated intercom stations, and one control station for the Police Detention Area for the amount not to exceed \$38,397.48.

Fire Department

INTRODUCTION AND HISTORY

The Auburn Hills Fire Department is seeking approval to purchase 15 new sets of structural firefighting turnout gear. This purchase is essential to ensuring the continued safety and effectiveness of our firefighters during emergency operations. Our current inventory includes gear that is approaching or has exceeded the recommended service life.

The department has evaluated various turnout gear manufacturers and has found Lion brand turnout gear to be the preferred option.

Lion is a globally recognized manufacturer of structural firefighting gear, currently in use by leading departments such as FDNY, Detroit, Chicago, Seattle, Houston, and many others. Auburn Hills has used Lion gear for over 10 years and have found it to be a reliable high-quality product. While there are other brands offering similar products, the lion brand offers a few valuable features that cannot be found elsewhere.

V-Force Cut: Ergonomically engineered pleating for better movement.

Magnetic Storm Flap System: This replaces the traditional Velcro flap that covers the main zipper in front of the gear. This system closes automatically, reduces wear, and simplifies the donning/doffing process.

ISO-DRI™ Technology: A patented moisture management system that reduces water retention within the lining of the gear, resulting in significantly lighter gear during operations and significantly faster drying times (within 4 hours on a rack, without fans or dryers).

Phoenix Safety Outfitters is the sole regional supplier for Lion turnout gear. The department has purchased gear through this supplier for over 10 years. We have consistently received excellent pricing and customer service.

The department received a proposal through the Sourcwell Government Cooperative Purchasing Program, which the city has used for multiple capital purchases in the past. The Sourcwell Purchasing Program meets the purchasing policy set forth by the City.

I recommend making a purchase of 15 sets of Lion brand turnout gear through Pheonix Safety Outfitters under the Sourcwell contract # 010424-LIO. The price per set is \$3,984.00 with a total for 15 sets being \$59,760.00. The department has been awarded a grant through the Michigan Turnout Gear program to cover \$3,500.00 per set. This leaves the city responsible for \$484.00 per set, for a total cost to the city of \$7,260.00 for the 15 sets.

Motion: Move to recommend to City Council the purchase of fifteen (15) sets of turnout gear from Phoenix Safety Outfitters through Sourcwell in the amount not to exceed \$59,760.00.

Human Trafficking

On May 9th, Officer Brasil located an advertisement on the internet for someone who was offering sexual acts for money at a local hotel. The suspected prostitute was located as she arrived at the hotel and stopped by officers. The female, a 21-year-old from Detroit, eventually admitted involvement in prostitution activity and explained that she was being controlled by a male she met on the internet. This case was turned over the Human Trafficking Task Force for further investigation.

Retail Fraud

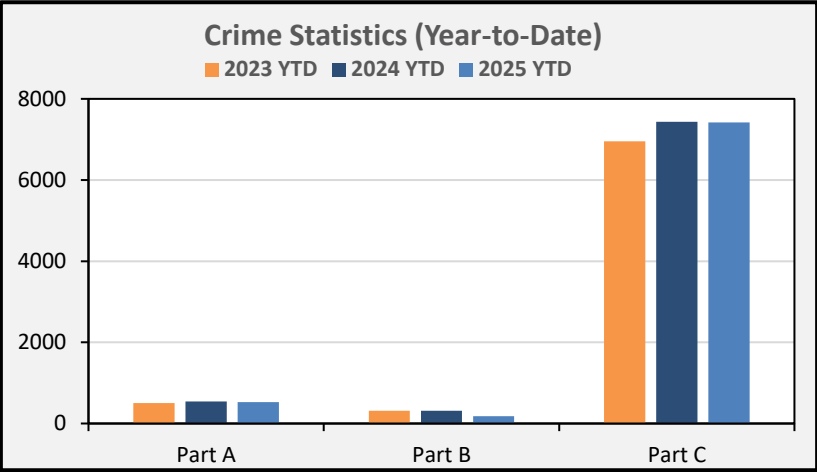
On May 17th, Officer Eckel was on patrol at Great Lakes Crossing Outlets when she observed a male walking out of the mall with a large bag, followed by a female yelling that the male had just stolen. Officer Eckel conducted a traffic stop on the suspect vehicle, which was driven by a 28-year-old male from Pontiac. The investigation determined that the suspect had taken approximately \$500 from the mall. Over \$1000 in stolen merchandise was located in the suspect vehicle, which was later determined to have been stolen on other dates. The Oakland County Prosecutor’s Office authorized charges for Retail Fraud First Degree.

Fraud

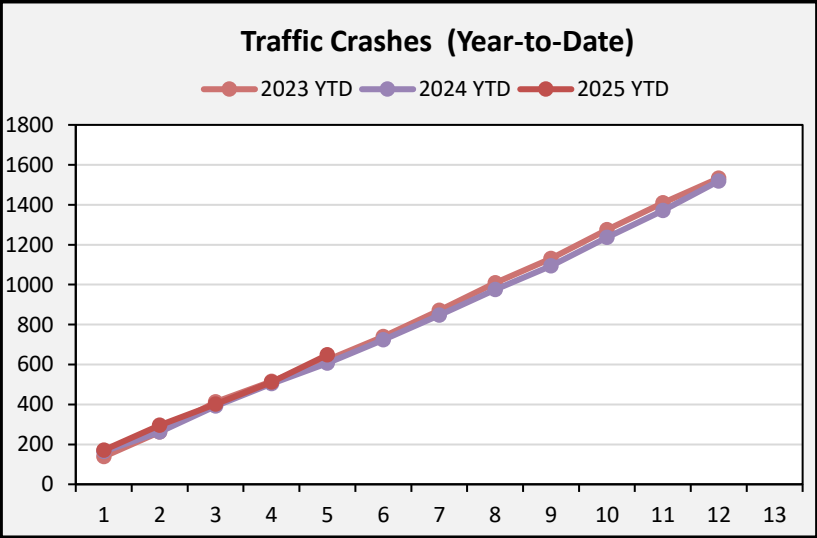
On May 20th, the Michigan State Police alerted that there were three individuals believed to be inside Great Lakes Crossing Outlets who were responsible for approximately \$25,000 in fraud upstate. Officers located all three suspects and detained them. One of the suspects, a 36-year-old male from Florida, had a credit card reader on his person, along with a large sum of cash and numerous credit cards with different names on them. He could not explain why he had possession of these items. The Oakland County Prosecutor’s Office authorized charges for Stealing/Retaining a Financial Transaction Device Without Consent & Possession of a Counterfeit/Forged State ID Card. The other individuals were turned over to the Michigan State Police for investigation into their alleged fraud.

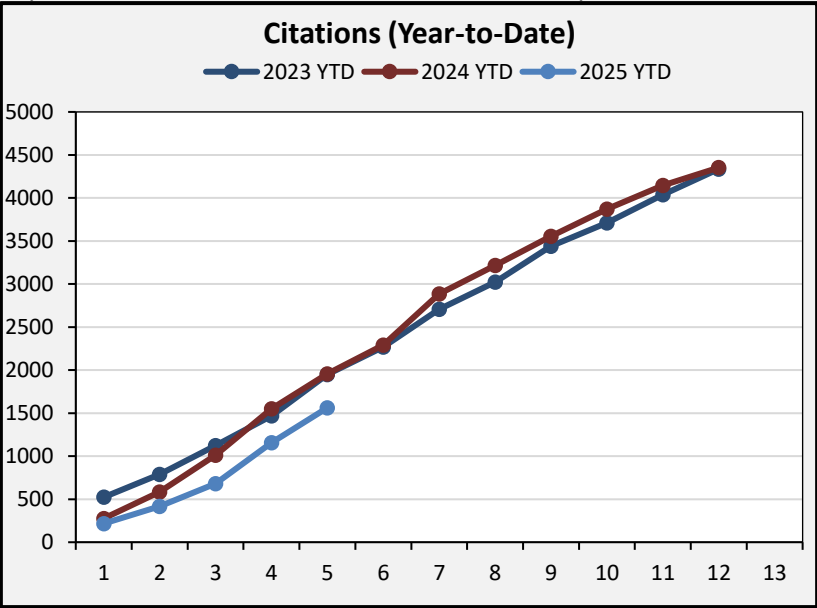

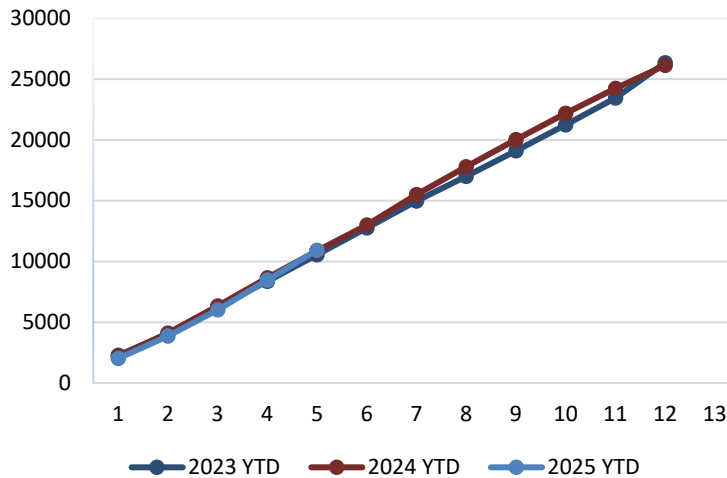

Calls for Service

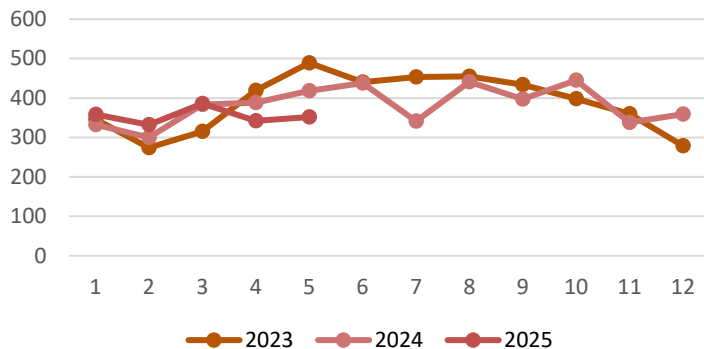
Calls for Service (Year-to-Date)



Officers handled 2441 calls for service during May. Year to date the department has handled 10,915 calls for service, which is a 0% change compared to 2024.

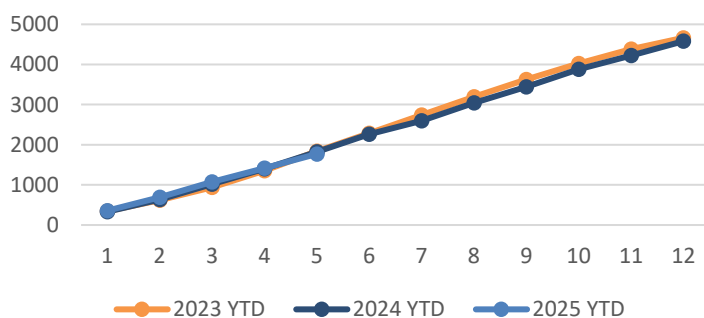
Time in Neighborhoods

Cumulative Time in Neighborhoods (Year-to-Date)

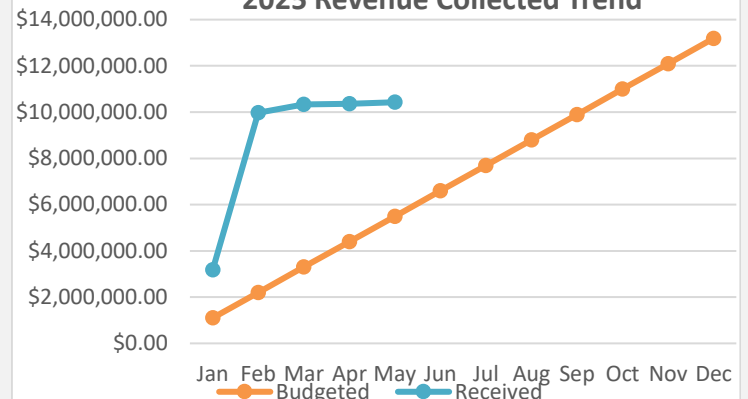

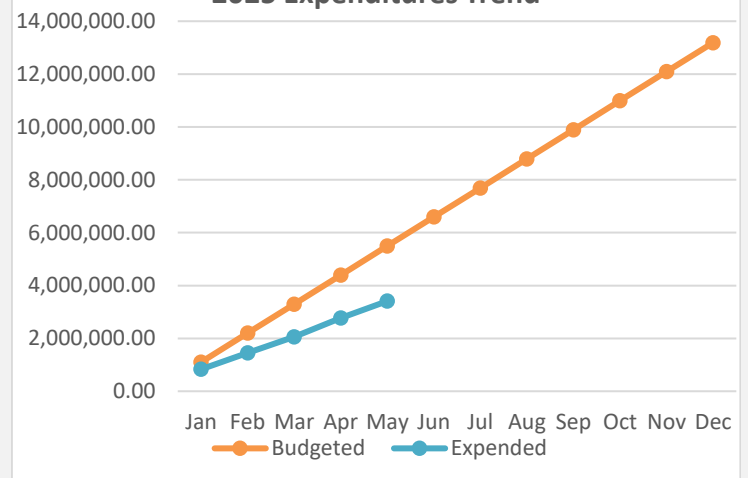

During May, we received \$62,916 in revenue. Year to date we have received \$10,426,165.

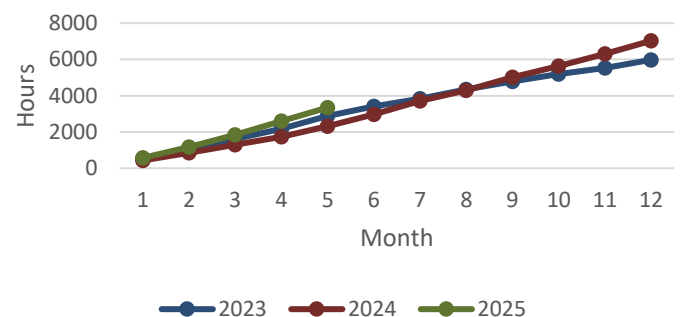
2025 Expenditures Trend

Re-Accreditation

In May, the police department earned its re-accreditation through the Michigan Association of Chiefs of Police (MACP). Auburn Hills is one of 94 law enforcement agencies in Michigan that have earned this distinction. In June, Chief Gagnon and Lieutenant Stubbs were presented with the re-accreditation certificate.



Stolen Vehicle

On June 4th, a resident on Sheffield Road called 911 because she awoke to her dogs barking at 4:00 AM then her car was stolen from her driveway. The victim tracked the vehicle, and it was located a short time later in Troy. The Oakland County Sheriff's Office pursued the stolen vehicle, which eventually stopped, and the occupants escaped on foot. Both occupants were located and arrested. The arrestees were a 20-year-old male and a 25-year-old male, both from Detroit. The stolen vehicle was returned to the owner. The Oakland County Prosecutor's Office authorized charges for Unlawful Driving Away of a Motor Vehicle and for Driving with a Suspended License.

Retail Fraud and Flee & Elude

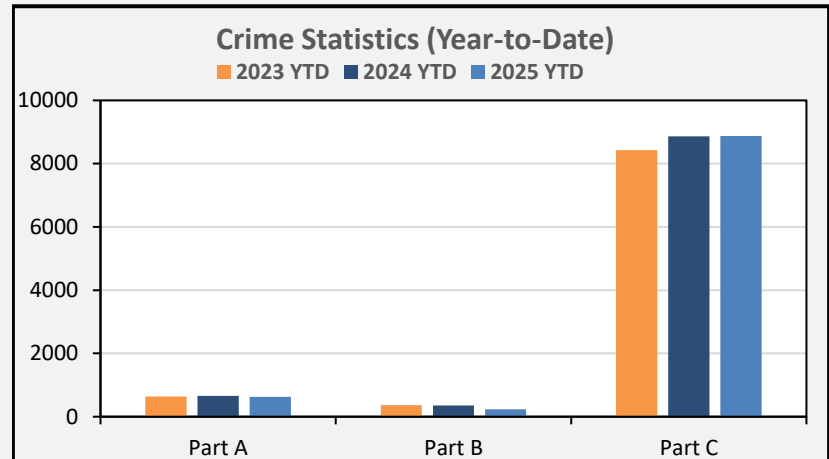
On June 10th, Officer VanVeelen was dispatched to Great Lakes Crossing Outlets for a report of a retail fraud where the suspects were leaving. Officer VanVeelen located the vehicle, which stopped for the traffic stop, but took off before any contact was made. The vehicle drove away and then crashed nearby. Two of the suspects/occupants were located and arrested nearby. A third occupant escaped. The Oakland County Prosecutor's Office authorized charges for all three suspects: a 31-year-old male, a 30-year-old male, and a 24-year-old female, all from Flint.

Carrying a Concealed Weapon

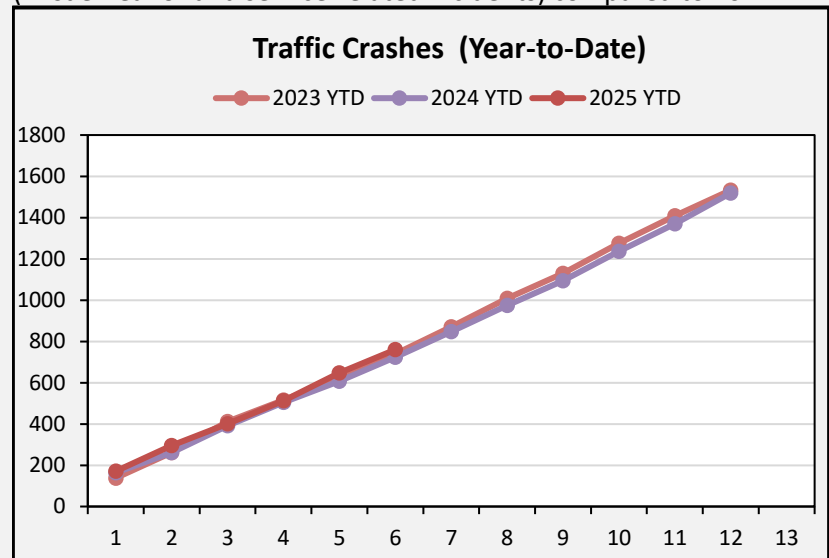
On June 27th, Officer Sims and Officer Bryant were patrolling the hotels when they located a vehicle where the occupants appeared to be loitering. When they made contact with the occupants to investigate, the driver ran off on foot. As the suspect was running through the parking lot, he discarded a handgun. The suspect, a 22-year-old male from Flint, was captured in the parking lot and arrested. The handgun was unregistered. The Oakland County Prosecutor's Office authorized charges for Carrying a Concealed Weapon and Assault/Resist/Obstruct Police.

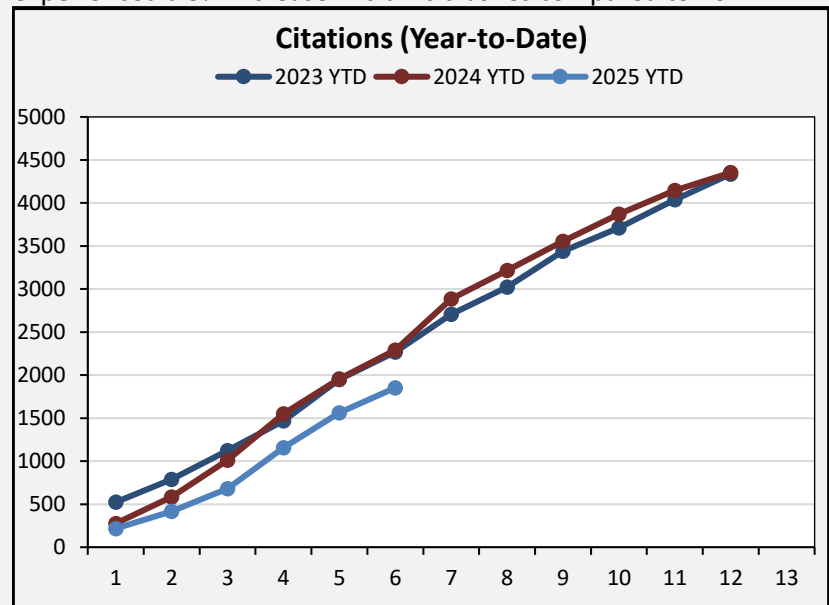

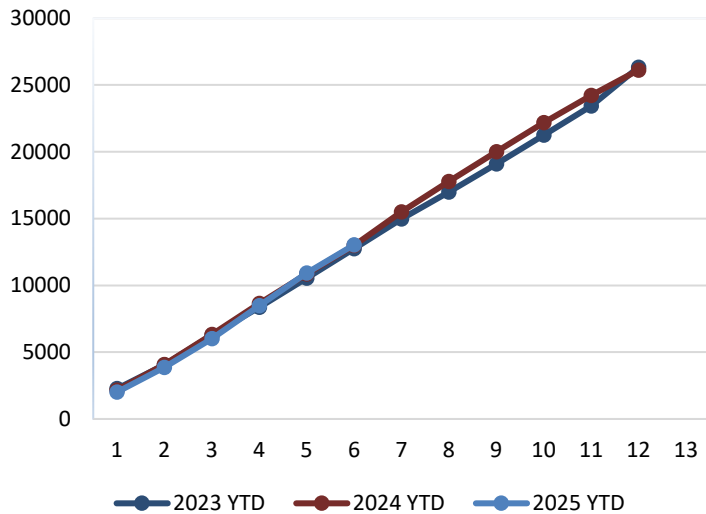

Calls for Service

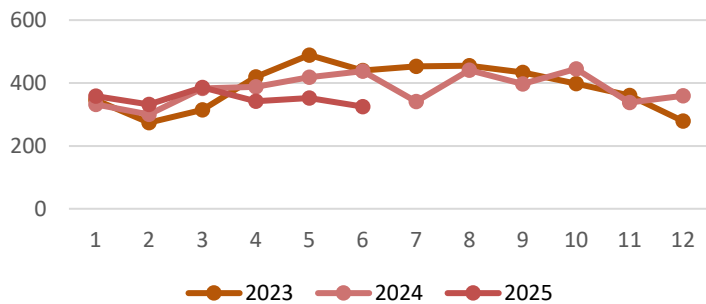
Calls for Service (Year-to-Date)



Officers handled 2115 calls for service during June. Year to date the department has handled 13,030 calls for service, which is a 0% change compared to 2024.

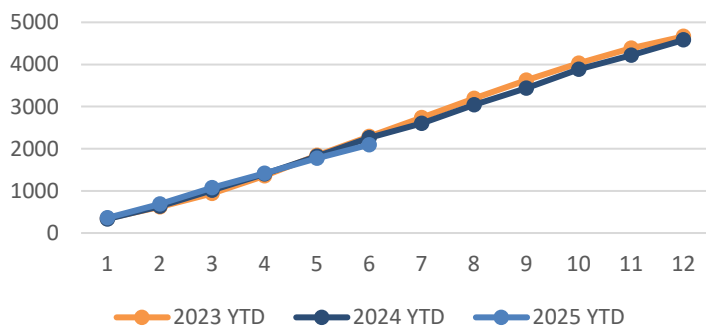
Time in Neighborhoods

Cumulative Time in Neighborhoods (Year-to-Date)

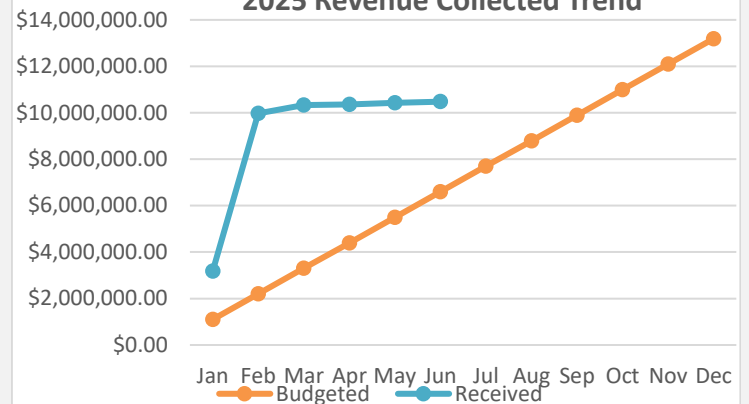

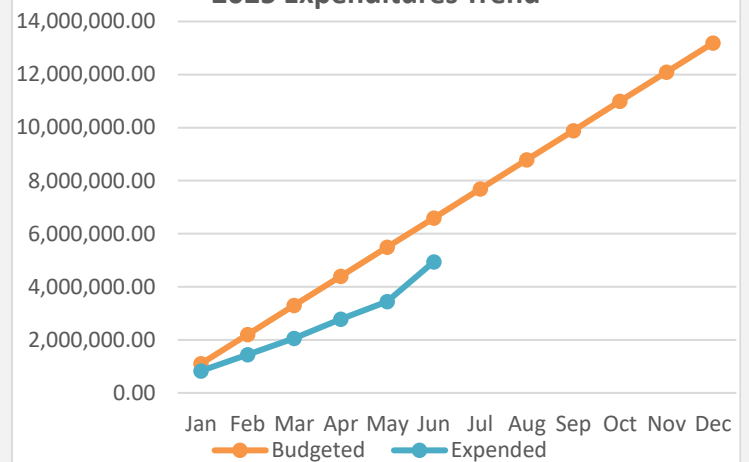

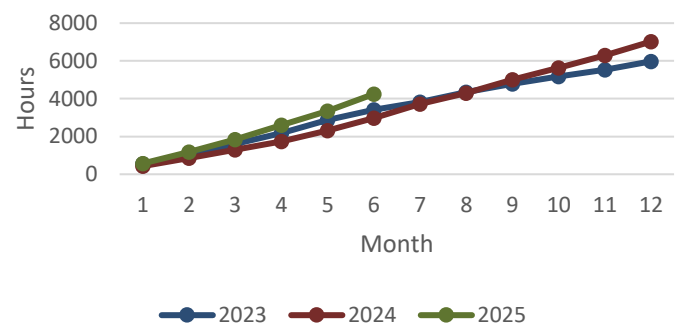
2025 Expenditures Trend

On July 31st, Officer Mahon visited Dutton Family Farm for a safety talk with adults with disabilities.

Criminal Sexual Conduct

In June, two females reported that a male suspect approached them and inappropriately touched them while on the Clinton River Trail. Using video from Avondale High School cross-referenced with Flock camera information, Detective Wagenmaker and Officer Saikalis located the suspect vehicle and developed a suspect, a 20-year-old male from Auburn Hills. The suspect eventually admitted to the acts, along with other inappropriate sexual acts in other jurisdictions. The victims positively identified the suspect, and he was arrested.

The Oakland County Prosecutor's Office authorized charges for Criminal Sexual Conduct-4th Degree.

Carrying a Concealed Weapon

On July 7th, around 3 AM, Officers Bear and O'Connell made a traffic stop on a vehicle for suspicious activity and equipment violations. The driver, a 27-year-old male from Pontiac, did not have a driver's license, and there was a handgun magazine in the vehicle in open view. When the driver was removed from the vehicle, a loaded silver handgun was found on the floorboard near where his feet had been, and a rifle was found under the driver's seat. Additionally, an unloaded rifle was found in the trunk along with a large quantity of packaged marijuana. The arrestee admitted that the firearms were his.

The Oakland County Prosecutor's Office authorized charges for Carrying a Concealed Weapon and Possession of a Loaded Firearm in a Vehicle.

Carrying a Concealed Weapon

On July 11th, Officer VanVeelen stopped a vehicle due to the driver having an outstanding warrant. The driver, a 35-year-old male from Pontiac, was placed under arrest. The driver told officers that he had a loaded handgun in the car, and it was located in a bag on the passenger seat.

The Oakland County Prosecutor's Office authorized charges for Carrying a Concealed Weapon.

Narcan Save

On July 25th, Officers Lane, Buecher, and Pointer were dispatched to The Suburban Studios hotel for a report of an unresponsive female who was overdosing on narcotics and fentanyl. When officers arrived, she was unresponsive. She regained consciousness after officers administered Narcan to her, and she was turned over to AHFD for further care.

Accidental Shooting

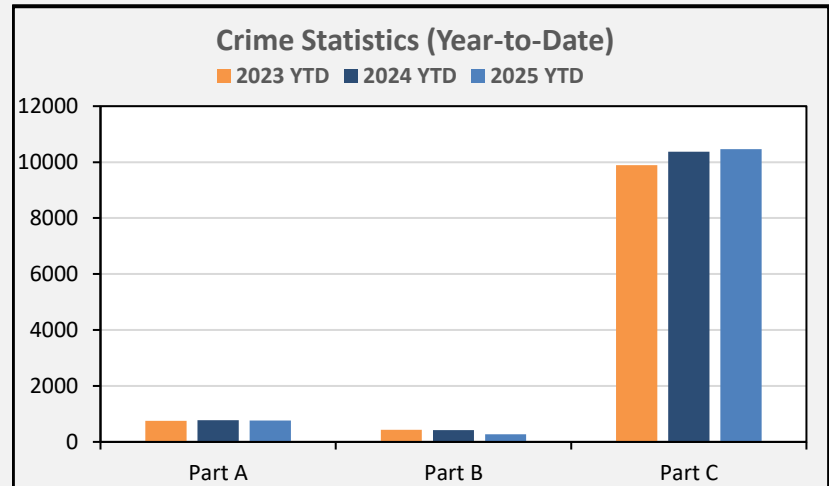
On July 28th, officers were dispatched to Great Lakes Crossing Outlets for a report of a female who was accidentally shot in the hip in the parking lot.

The investigation determined that a 26-year-old male from Madison Heights was handling his firearm inside his vehicle when he accidentally depressed the trigger. The gun fired and struck the male's friend, an 18-year-old female from Pontiac, in the hip area. Her injuries were not life-threatening, and she was taken to a local hospital for treatment.

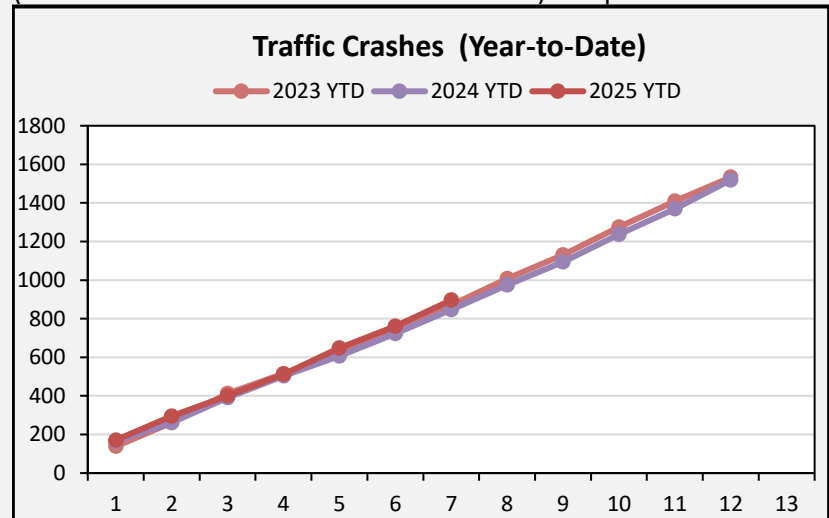

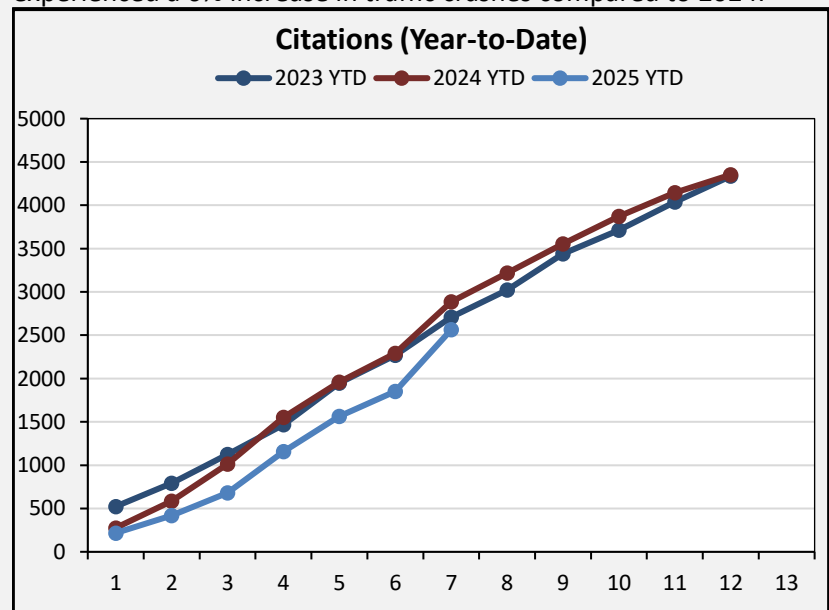

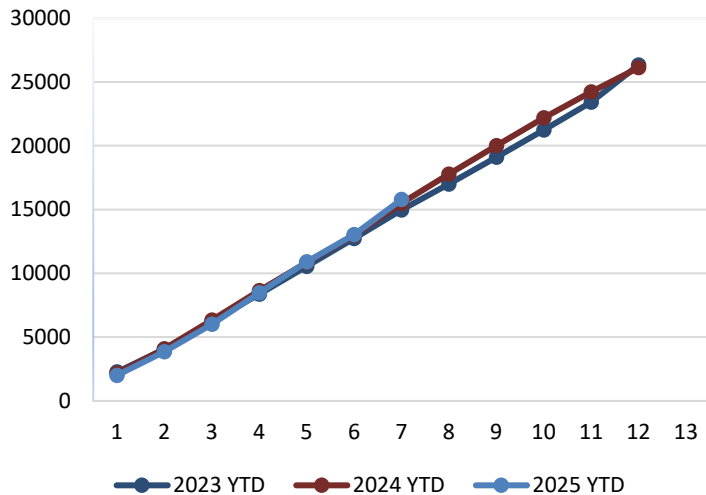
During July, we handled 136 crashes. Year to date, we have experienced a 6% increase in traffic crashes compared to 2024.

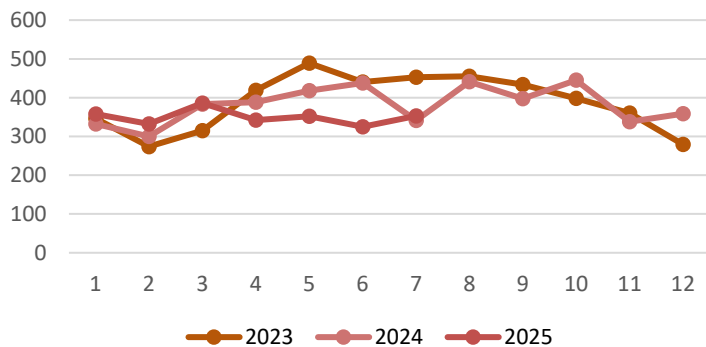
Calls for Service (Year-to-Date)



Officers handled 2757 calls for service during July. Year to date the department has handled 15,787 calls for service, which is a 2% change compared to 2024.

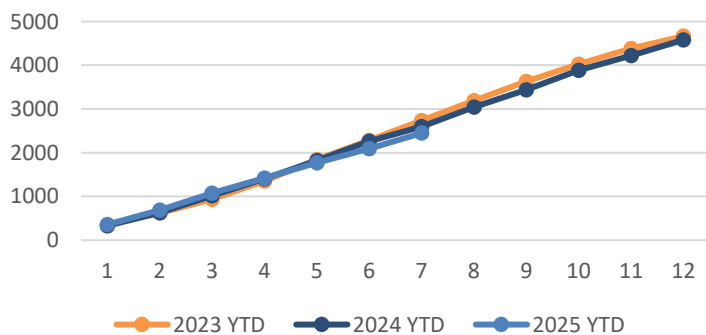
Time in Neighborhoods

Cumulative Time in Neighborhoods (Year-to-Date)

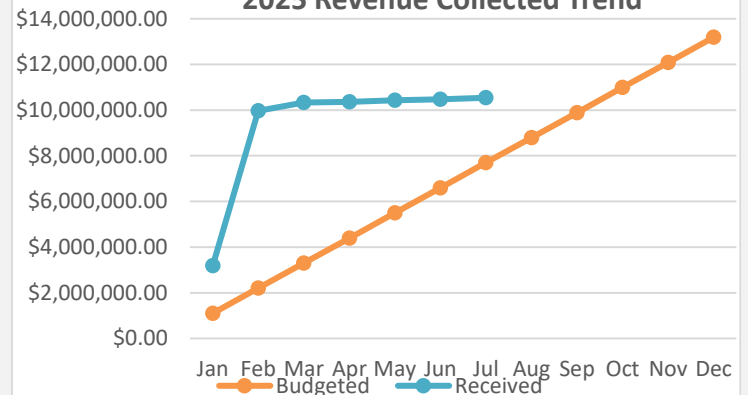

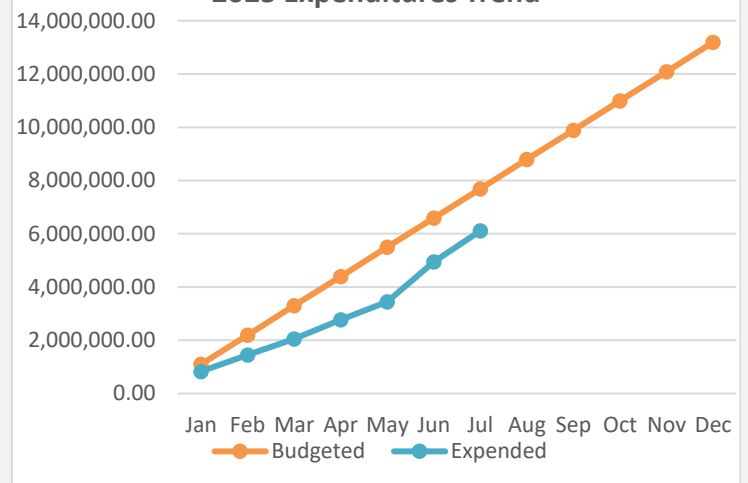

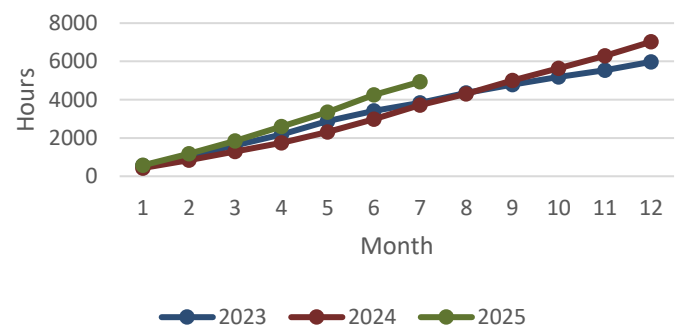
2025 Expenditures Trend

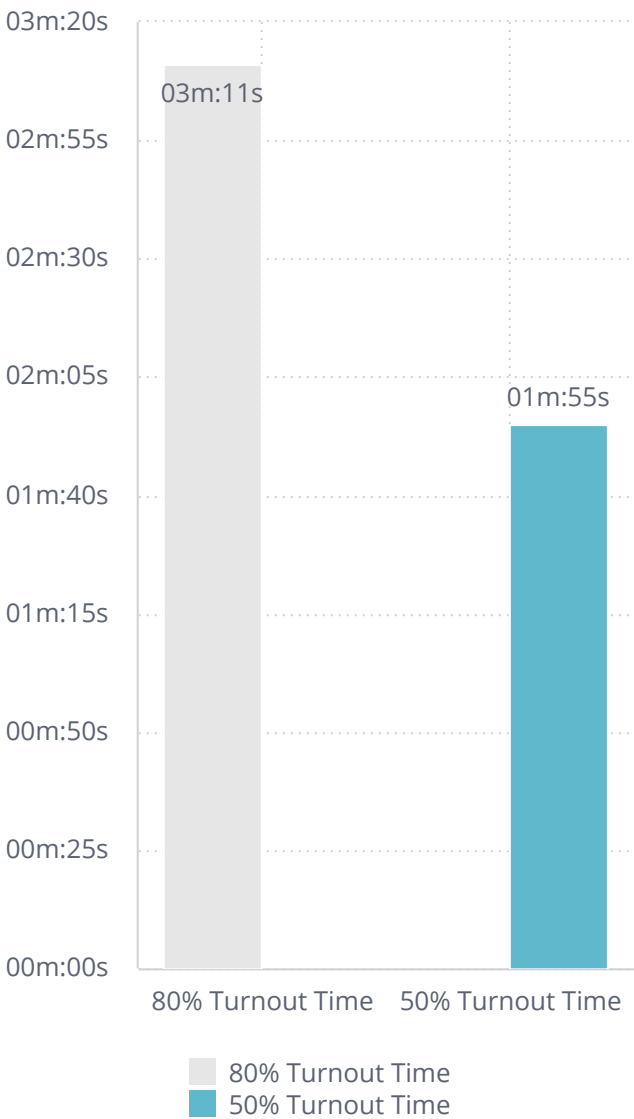

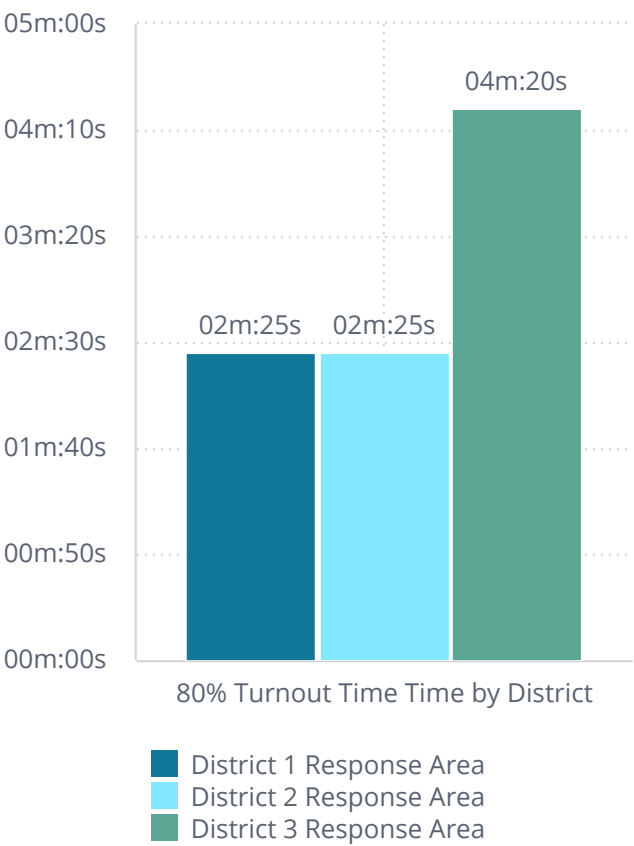

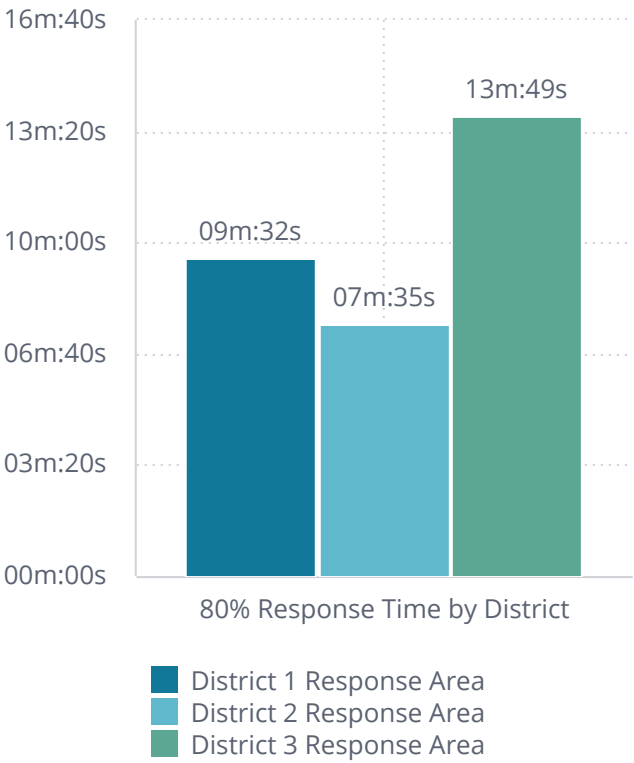

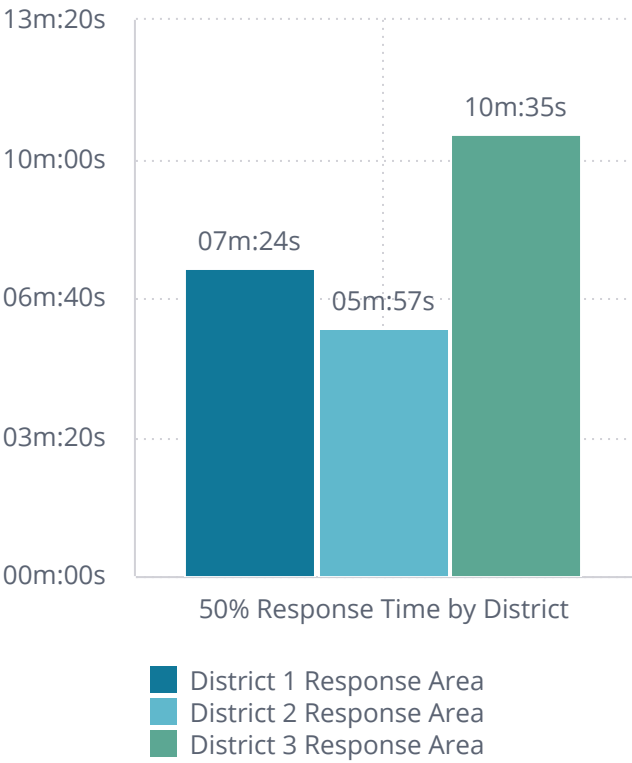

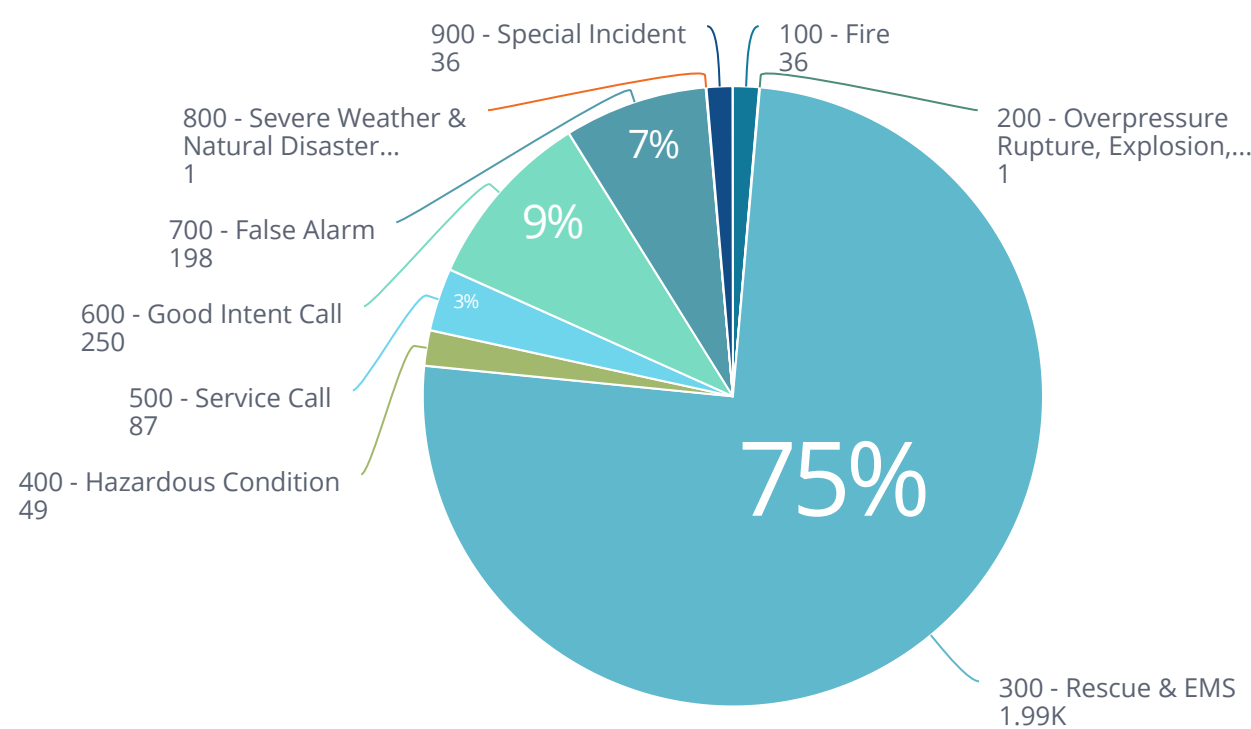
Estimator Property Value & Loss

Percentage of Responses by Incident Type



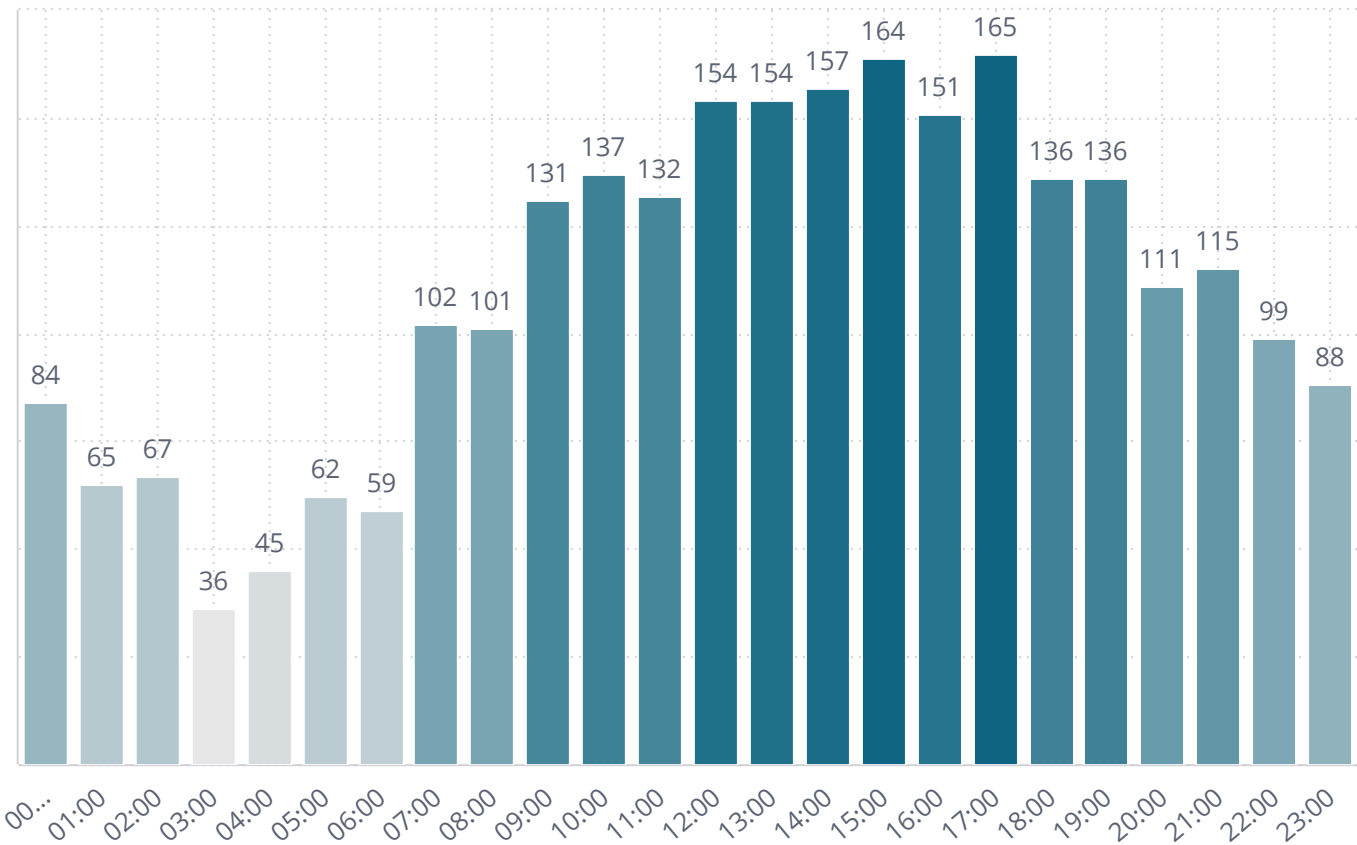

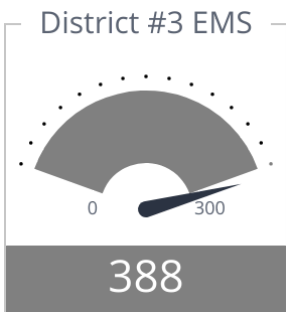

Department Response Time for All EMS Incidents

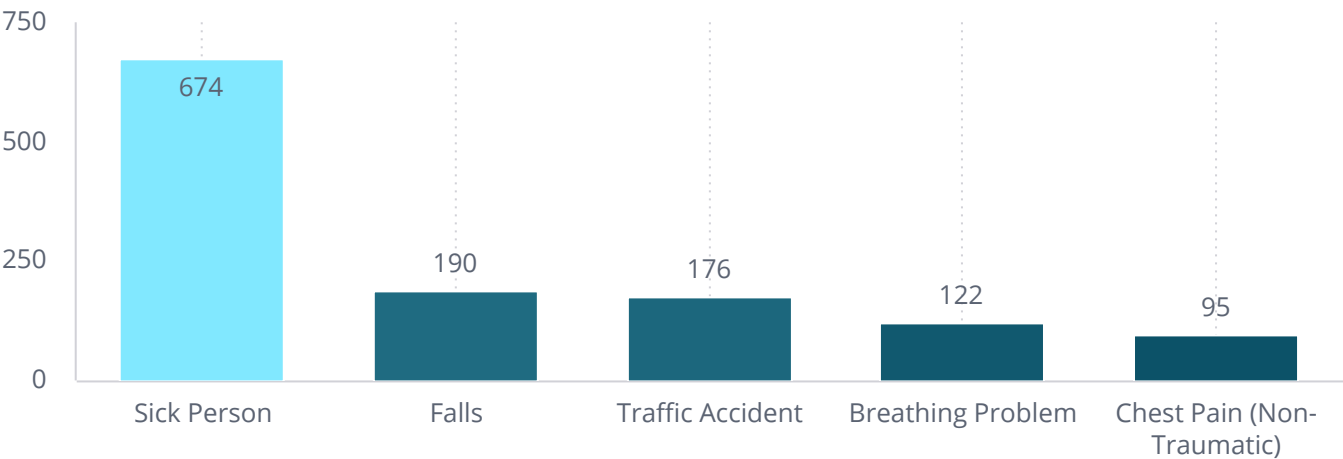


Department Response Time for Priority 1 EMS Incid...

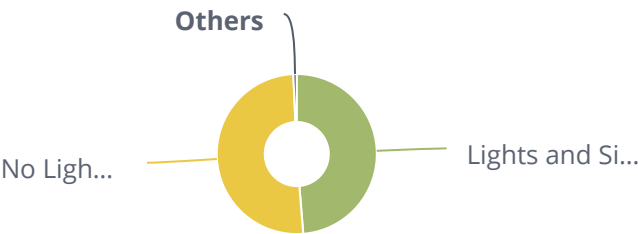

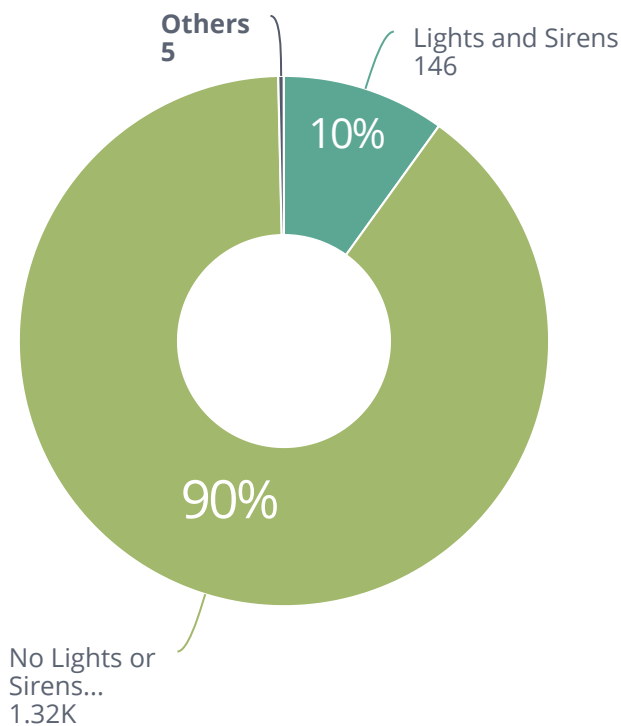

5/24/2025



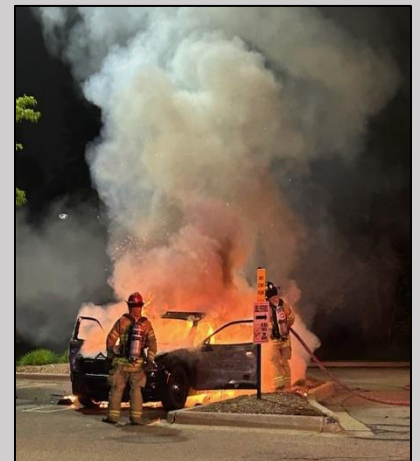

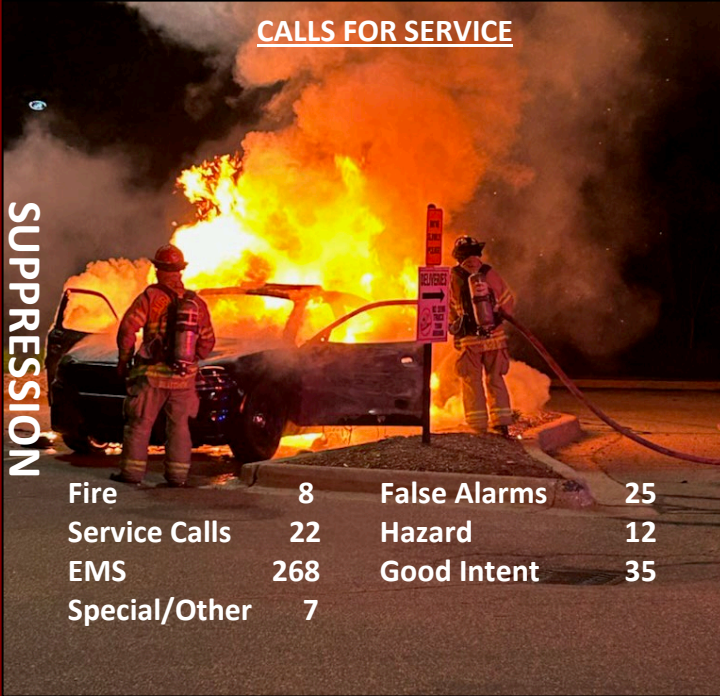

Residential Fire

6/07/2025

A-shift was called to a structure fire at a local apartment complex. Upon arrival, Engine 3 crew found brown, hazy smoke inside the building. A small fire was located in the kitchen area and quickly extinguished with tank water. The fire was investigated by an inspector who, based on available evidence, found the fire to be accidental in nature. No injuries were reported.



SCBA Fill Station

6/10/2025

Self-Contained Breathing Apparatus (SCBA) is a portable breathing device used by firefighters when they enter an Immediately Dangerous to Life or Health (IDLH) environment. The bottles must be filled after each use. This is done by means of a fill station. The old fill station was 25 years old and in need of replacement. This month, the department took possession of the new fill station, which was funded by a grant. Firefighters were trained in proper usage of this equipment. Obtaining the new fill station ensures SCBA bottles are filled correctly and safely, reducing the risk of over-pressurization or contamination.



Vehicle Fire

6/15/2025

C-Shift responded to a call for a vehicle on fire in the parking lot of a towing company. Upon arrival, the crew found a working fire in a vehicle that was spreading to nearby vehicles. Engine 3 and Ladder 2 firefighters used tank water to knock down the fire in both the ~CONT.

SUV and the pickup truck next to it. No injuries were reported.

7/18/2025

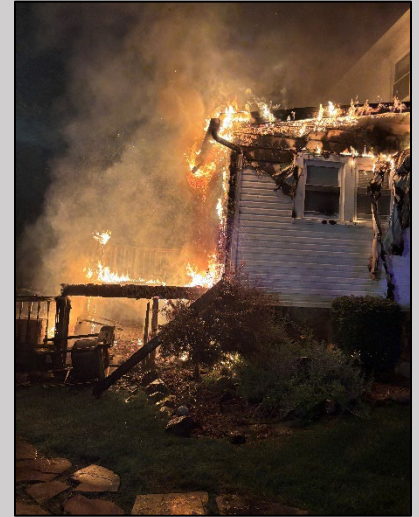
Dispatch notified A-shift of a dumpster fire in a parking lot. Engine 3 arrived at the scene of a fire confined to the dumpster. The fire was quickly extinguished with foam and tank water, preventing it from spreading.



Structure Fire

7/22/2025

C-Shift responded to a call for a residential structure on fire. Crews arrived to find the attached deck and rear of home were on fire. The homeowner was safely out of the house. Engine 3 crew stretched 1.75" handlines to begin the fire attack. Once the fire was knocked down, firefighters forced their way through the rear door to fight the fire inside the kitchen. AHFD completed extensive overhaul on the kitchen, removing roofing, siding, soffits and fascia in order to completely extinguish the fire. The investigation revealed the fire started on the deck outside the residence and spread before firefighters arrived. AHPD's fire investigator handled the investigation.



Vehicle Fire

7/25/2025

Dispatch toned C-shift for a vehicle fire in the parking lot of Best Buy. Crews arrived to find a fully involved car fire. Firefighters used tank water and foam from Engine 3 to battle the blaze. The driver of the vehicle immediately pulled over to call 911 after noticing a strange odor and seeing smoke and flames coming from the dash. No injuries were reported.
